4 **ORDINANCE 2024-377-E**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE  
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER AN AMENDMENT TO  
8 THE FISCAL YEAR 2023-2024 CITY GRANT AGREEMENT  
9 BETWEEN THE CITY OF JACKSONVILLE AND CLARA WHITE  
10 MISSION, INC. (THE "AGREEMENT"), TO EXTEND THE  
11 TERM OF THE AGREEMENT TO EXPIRE ON FEBRUARY 28,  
12 2025 AND EXTENDING CERTAIN OTHER RELATED DATES  
13 AND DEADLINES WITHIN THE AGREEMENT; PROVIDING  
14 FOR CARRYOVER OF FUNDS APPROPRIATED BY ORDINANCE  
15 2023-608-E TO FISCAL YEAR 2024-2025; PROVIDING  
16 FOR CONTINUED OVERSIGHT BY THE GRANTS AND  
17 CONTRACT COMPLIANCE DIVISION; PROVIDING AN  
18 EFFECTIVE DATE.

20 **WHEREAS**, Ordinance 2023-608-E appropriated \$300,000 and  
21 authorized the Mayor, or her designee, and the Corporation Secretary,  
22 to execute, on behalf of the City, a grant agreement between the City  
23 and Clara White Mission, Inc. ("Clara White"), for the White Harvest  
24 Farms Culinary Vocational Training Program (the "Program"); and

25 **WHEREAS**, the term of the Fiscal Year 2023-2024 City Grant  
26 Agreement between the City of Jacksonville and Clara White Mission,  
27 Inc. (the "Agreement") is currently set to expire on September 30,  
28 2024; and

29 **WHEREAS**, Clara White has requested an extension to the term of  
30 the Agreement to accommodate the additional time it took to fully set  
31 up the Program; and

1           **WHEREAS,** the City Council therefore desires to extend the term  
2 of the Agreement to February 28, 2025, and to carryover the funds set  
3 aside to fund the Program, to fiscal year 2024-2025; now therefore

4           **BE IT ORDAINED** by the Council of the City of Jacksonville:

5           **Section 1. Approval and Authorization to Execute an**  
6 **Amendment to Agreement.** There is hereby approved, and the Mayor, or  
7 her designee, and the Corporation Secretary are hereby authorized to  
8 execute and deliver, that certain First Amendment to the Fiscal Year  
9 2023-2024 City Grant Agreement between the City of Jacksonville and  
10 Clara White Mission, Inc., in substantially the same form attached  
11 hereto as **Exhibit 1** and incorporated herein by this reference, to  
12 extend the term of the Agreement to February 28, 2025, in addition  
13 to an extension of related dates for submittal of reimbursement  
14 requests and documentation, and deadlines to request budget  
15 amendments and quarterly reports, with all other terms and conditions  
16 of the Agreement remaining unchanged.

17           **Section 2. Carryover.** The funds appropriated pursuant to  
18 Ordinance 2023-608-E to fund the White Harvest Farms Culinary  
19 Vocational Training Program remaining at the end of fiscal year 2023-  
20 2024 shall not lapse but shall carryover to fiscal year 2024-2025.

21           **Section 4. Oversight.** The Grants and Contract Compliance  
22 Division of the Department of Finance and Administration shall  
23 continue to have oversight of the Agreement described herein.

24           **Section 5. Effective Date.** This Ordinance shall become  
25 effective upon signature by the Mayor or upon becoming effective  
26 without the Mayor's signature.
