The Kids Hope Alliance is requesting legislation to make changes to the Kids Hope Alliance Mini-Grants Program, Sec. 111.850 Part A. This requested legislation is on the agenda to be approved by the Kids Hope Alliance Board of Directors on July 17, 2019. The requested legislation will amend Section 111.850 Part A to change the maximum award of the Kids Hope Alliance Mini-Grants Program from \$5,000 to \$25,000. This change will allow the Kids Hope Alliance to fund new and innovative programs, as well as new providers and initiatives that fit within the scope of the Essential Services Plan and overall continuum of services.

This legislation requires no new appropriation or transfers of funding. All approved mini-grants will continue to be awarded through the Kids Hope Alliance Trust Fund as outlined in Section 111.850 Part A.


