6 (\$606,167.27 IN GRANT FUNDS FROM THE DEPARTMENT
7 OF HOMELAND SECURITY/FEDERAL EMERGENCY
8 MANAGEMENT AGENCY AND \$60,616.73 CASH MATCH FROM
9 THE CITY) FOR THE CITY OF JACKSONVILLE FIRE AND
10 RESCUE DEPARTMENT'S WELLNESS AND FITNESS
11 PROGRAM, AS INITIATED BY B.T. 21-133; PURPOSE OF
12 APPROPRIATION; PROVIDING FOR OVERSIGHT BY
13 JACKSONVILLE FIRE AND RESCUE DEPARTMENT;
14 PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
18 within the City's budget, there are hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above represents an appropriation of
29 \$606,167.27 in Assistance to Firefighters Grant funding
30 from the Department of Homeland Security/Federal Emergency
31 Management Agency distributed by the Florida Department of

1 Emergency Management and funded through the American Rescue
2 Plan Act of 2021 and an additional appropriation of
3 \$60,616.73 from the City. These funds will be used to
4 assist the Jacksonville Fire and Rescue Department with
5 enhancing and supporting the JFRD's Wellness and Fitness
6 Program. The grant period commences July 3, 2021 through
7 July 29, 2023.

8 **Section 2. Purpose.** The purpose of the appropriation in
9 Section 1 is to support City of Jacksonville Fire and Rescue
10 Department's Wellness and Fitness Program with funding for Peer
11 Support Training for ten members, Peer Fitness Certification for
12 twenty-five members, and Physical Therapy Services, Physical Strength
13 and Conditioning Exercise Equipment, Exercise Equipment Preventative
14 Maintenance and Repair Services, Firefighter Candidate CPAT Testing
15 Equipment, and Physical Exam/ Health Screening Equipment and
16 Supplies. A copy of the Federally-Funded Assistance to Firefighters
17 Grant Agreement (Award Number: EMW-2020-FG-10216) providing the terms
18 and conditions relative to receipt and expenditure of the grant funds
19 has been placed **On File** with the Office of Legislative Services.

20 **Section 3. Oversight.** The Jacksonville Fire and Rescue
21 Department, Emergency Preparedness Division shall oversee
22 administration of the grant described herein.

23 **Section 4. Effective Date.** This Ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
