27 member that lives within one mile of the CRA boundary representing
28 the general public, pursuant to section 53.202 (Membership;
29 appointment and removal; terms of office), Part 2 (KingSoutel Crossing
30 Community Redevelopment Agency Advisory Board), Chapter 53 (Community
31 Redevelopment Agency Advisory Boards), *Ordinance Code*, for a first
