ORDINANCE 2025-282-E

AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING AND STREET NAMING REGULATIONS), ORDINANCE CODE; RENAMING A PORTION OF ROADWAY CURRENTLY IDENTIFIED AS "SWOOPING WILLOW COURT" "SWOOPING WILLOW COURT WEST" IN COUNCIL DISTRICT 6; WAIVING THE REQUIREMENT OF SECTION 745.105 (PUBLIC STREET NAME CHANGES), PART 1 (GENERAL PROVISIONS), CHAPTER 745 (ADDRESSING AND STREET NAMING REGULATIONS), ORDINANCE CODE, THAT THE PLANNING AND DEVELOPMENT DEPARTMENT SEND WRITTEN NOTIFICATIONS REGARDING THE PROPOSED STREET NAME CHANGE TO AFFECTED PROPERTY OWNERS; DIRECTING THE CHIEF OF THE LEGISLATIVE SERVICES DIVISION TO FORWARD A COPY OF THIS ORDINANCE, ONCE PUBLIC WORKS ENACTED, TO THEDEPARTMENT, DEVELOPMENT SERVICES AND TRAFFIC ENGINEERING DIVISIONS, FOR PROCESSING AND COORDINATION WITH 911 EMERGENCY, THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT, THE U.S. POSTAL SERVICE, AND OTHER AFFECTED AGENCIES AND ORGANIZATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Addressing Section of the Public Works Department, Development Services Division, received information from the Public Works Department, Traffic Engineering Division, regarding inconsistent City addressing data for a portion of roadway currently identified as Swooping Willow Court; and

 WHEREAS, specifically, the City addressing data indicates that Swooping Willow Court is divided into two separate street segments where one segment contains a "West" directional designation ("Swooping Willow Court West") while the other segment does not contain a directional designation ("Swooping Willow Court"); and

WHEREAS, currently, eight street addresses are assigned to Swooping Willow Court and fourteen street addresses are assigned to Swooping Willow Court West; and

WHEREAS, a recent site visit conducted by Addressing Section staff revealed that all 22 residents are using Swooping Willow Court West as their official street address although a City street sign is in place for Swooping Willow Court without the "West" directional designation; and

WHEREAS, JEA and the Duval County Property Appraiser's Office data also reflect the assignment of Swooping Willow Court West to all 22 residents; and

WHEREAS, the renaming of the affected portion of Swooping Willow Court to Swooping Willow Court West will correct existing City of Jacksonville addressing data as well as provide consistency with other agencies' addressing data for this segment of roadway; and

WHEREAS, upon this legislation becoming effective, the City will install a new street sign at the affected roadway segment to reflect "Swooping Willow Court West" as the designated street name; and

WHEREAS, the Public Works Department, Development Services Division, issued a staff recommendation to approve the renaming of "Swooping Willow Court" to "Swooping Willow Court West" and a copy of said recommendation is attached hereto as Exhibit 1 and incorporated herein by this reference; and

WHEREAS, on January 8, 2025, the 911 Emergency Addressing Advisory Committee considered this matter during a public meeting and

voted to accept the staff recommendation to rename "Swooping Willow Court" to "Swooping Willow Court West" and a copy of the minutes of said meeting is attached hereto as **Exhibit 2** and incorporated herein by this reference; and

WHEREAS, in addition, the Community Planning Division,
Historic Preservation Section, of the Planning and Development
Department issued a Memorandum with a recommendation to approve the
renaming of "Swooping Willow Court" to "Swooping Willow Court West"
and a copy of said staff recommendation is attached hereto as Exhibit

3 and incorporated herein by this reference; and

WHEREAS, on March 26, 2025, the Jacksonville Historic Preservation Commission ("JHPC") held a public meeting where it considered this matter and voted to accept the Historic Preservation Section's recommendation to rename "Swooping Willow Court" to "Swooping Willow Court West" and a copy of the minutes of said meeting is attached hereto as Exhibit 4 and incorporated herein by this reference; and

WHEREAS, the City Council desires to correct this matter by renaming the affected portion of "Swooping Willow Court" to "Swooping Willow Court West"; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Swooping Willow Court Renamed as "Swooping Willow Court West". The portion of roadway currently identified as "Swooping Willow Court" is hereby renamed to "Swooping Willow Court West" by which name such street and physical location shall be hereafter known and designated. A copy of the map of Swooping Willow Court West is included with the Development Services staff recommendation packet attached hereto as Exhibit 1.

Section 2. Waiver of Certain Requirements of Section 745.105, Ordinance Code. The requirement of subsection 745.105(c), Ordinance Code, that the Planning and Development Department send

written notifications of the proposed street name change to affected property owners is hereby waived as the eight affected residents are already using Swooping Willow Court West as their official address.

Division. The Chief of the Legislative Services Division is hereby directed to send a copy of this Ordinance, once enacted, to the Public Works Department, Development Services and Traffic Engineering Divisions, for processing, implementation, and coordination with 911 Emergency, the Jacksonville Fire and Rescue Department, the U.S. Postal Service, and other affected agencies and organizations.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
