4 **ORDINANCE 2021-730**

5 AN ORDINANCE APPROPRIATING \$150,000.00 IN  
6 GENERAL FUND - GENERAL SERVICES FUND BALANCE TO  
7 PROCURE PROFESSIONAL SERVICES FOR THE  
8 JACKSONVILLE SMALL AND EMERGING BUSINESS  
9 PROGRAM, TO PROCURE PROFESSIONAL SERVICES  
10 PURSUANT TO CHAPTER 126 (PROCUREMENT CODE),  
11 *ORDINANCE CODE*; PURPOSE OF APPROPRIATION;  
12 PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, the City realized debt service interest savings in  
15 fiscal year 2020-21 that "rolled" to the fund balance of the general  
16 fund - GSD at fiscal yearend; now therefore

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
19 within the City's budget, there is hereby appropriated the indicated  
20 sum(s) from the account(s) listed in subsection (a) to the account(s)  
21 listed in subsection (b):

29 The appropriation above is a transfer of General Fund debt  
30 service interest savings in the amount of \$150,000.00 to  
31 fund professional services for the Jacksonville Small and

1 Emerging Business Program (the "JSEB Program").

2 **Section 2. Purpose.** The purpose of the appropriation in  
3 Section 1 is to procure professional services for the JSEB Program,  
4 pursuant to Chapter 126 (Procurement Code), *Ordinance Code*.  
5 Specifically, these funds will be used to procure cohort analytics  
6 software that will use block chain technology to measure learning  
7 outcomes and preserve data while also centralizing the Equal Business  
8 Opportunity Office's reporting functions.

9 **Section 3. Effective Date.** This Ordinance shall become  
10 effective upon signature by the Mayor or upon becoming effective  
11 without the Mayor's signature.
