5 AN ORDINANCE AMENDING SECTION 122.202(D)
6 (PARKING RATES AT MUNICIPAL PARKING LOTS), PART
7 2 (MUNICIPAL PARKING LOTS), CHAPTER 122 (PUBLIC
8 PROPERTY), *ORDINANCE CODE*, TO EXTEND THE
9 DISCOUNT RATE TO EMPLOYEES PARKING IN CITY OWNED
10 PARKING FACILITIES FOR AN ADDITIONAL ONE YEAR;
11 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
12 PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Amending Section 122.202(d) (Parking Rates at**
16 **Municipal Parking Lots), Ordinance Code.** Section 122.202(d) (Parking
17 rates at municipal parking lots), Part 2 (Municipal Parking Lots),
18 Chapter 122 (Public Property), *Ordinance Code*, is hereby amended to
19 read as follows:

20 **CHAPTER 122 PUBLIC PROPERTY.**

22 **PART 2. MUNICIPAL PARKING LOTS**

24 **Sec. 122.202- Parking rates at municipal parking lots.**

26 (d) Effective October 1, 2014, all City employees (which term
27 shall include all City of Jacksonville employees and employees of the
28 Duval County Supervisor of Elections, Duval County Property
29 Appraiser, Duval County Tax Collector, and Duval County Clerk of
30 Court and to employees of the Office of the Public Defender of the
31 Fourth Judicial Circuit, who are monthly parkers at municipal owned

1 parking facilities operated by the Office of Public Parking, shall
2 be entitled to a reduced monthly parking rate, which shall be fifty
3 percent (50%) of the established, monthly parking rate for the given
4 facility through September 30, 2022~~1~~. The Downtown Investment
5 Authority shall file the employee rate schedule and any subsequent
6 change to the employee rate schedule with the Council Secretary, and
7 such rates shall become effective upon such filing unless and until
8 the Council enacts an ordinance to the contrary.

10 **Section 2. Requesting one cycle emergency passage pursuant**
11 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
12 legislation is requested. The nature of the emergency is that the
13 existing reduced monthly parking rate for existing employees is set
14 to expire on September 30, 2021 and the Council would like to extend
15 the employee discount for an additional year prior to the expiration
16 date.

17 **Section 3. Effective Date.** This ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
