AN ORDINANCE APPROPRIATING \$60,000, INCLUDING \$10,000 TO SIGMA BETA CLUB OF JACKSONVILLE INC., \$10,000 TO DELTA SIGMA THETA SORORITY, INC., JACKSONVILLE ALUMNAE CHAPTER, \$10,000 TO KAPPA ALPHA PSI JACKSONVILLE FOUNDATION, INCORPORATED, \$10,000 TO BETA ALPHA ZETA CHAPTER OF ZETA PHI BETA SORORITY, INC., \$10,000 TO OMEGAS 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI PHI THETA PHI CHAPTER, INC.), AND \$10,000 TO ALPHA-JAX FOUNDATION, INC. (GAMMA RHO OMEGA CHAPTER, INC. (AFFILIATE OF OMEGA PSI PHI THETA PHI CHAPTER, INC.), AND ALPHA-JAX FOUNDATION, INC. (GAMMA RHO OMEGA CHAPTER, INC. OF ALPHA KAPPA ALPHA SORORITY) FOR THE PROGRAMS; PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2023-2024 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above is an appropriation of \$60,000 from Designated Contingency accounts within the General Fund to the Subsidies and Contributions to Private Organizations account within the Kids Hope Alliance ("KHA") Fund to provide funding for various youth programs and services as described herein, to include \$10,000 to Sigma Beta Club of Jacksonville Inc., \$10,000 to Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae Chapter, \$10,000 to Kappa Alpha Psi Jacksonville Foundation, Incorporated, \$10,000 to Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., \$10,000 to Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and \$10,000 to Alpha-Jax Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority).

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding from the City of Jacksonville to Sigma Beta Club of Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation, Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority), for the provision of youth programs and services in Duval County as more particularly described in the Term Sheets attached hereto as Exhibit 2 and incorporated herein by this reference (the "Programs"). The Programs are designed to encourage youth participants to engage in leadership

opportunities and to pursue higher education. Several of the Programs will use the City funding to provide expanded scholarship opportunities to eligible students who pursue higher education. In addition, several of the Programs will use the City funding to cover the costs for students and youth who desire to attend education and leadership conferences and/or trips to visit colleges and universities that are sponsored by the recipient organizations.

Section 3. Amending Fourth Revised Schedule M to Ordinance 2023-511-E. The Kids Hope Alliance fiscal year 2023-2024 budget approved by Ordinance 2023-511-E is hereby amended by substituting in the place of the Fourth Revised Schedule M, the Fifth Revised Schedule M, attached hereto as Exhibit 3 and incorporated herein by this reference. The Fifth Revised Schedule M reflects the funds appropriated herein.

Invoking the Exemption in Section 126.107(g), Section 4. Ordinance Code. The City is hereby authorized to directly procure the professional services of Sigma Beta Club of Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation, Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority), for the provision of youth programs and services. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempted from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Section 5. Waiving the Requirements of Section 77.111(a),

Ordinance Code. The City hereby waives the requirements of Section 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance), Ordinance Code, with respect to the contracts with Sigma Beta Club of Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation, Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority), approved and authorized by this Ordinance. Section 77.111(a) requires contracts for children's services provided by third parties to be competitively procured by KHA via an evaluated bid process. This waiver is needed in order to allow KHA to directly contract with Sigma Beta Club of Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville Chapter, Kappa Alpha Psi Jacksonville Alumnae Foundation, Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority), to provide the youth programs and services described in Exhibit 2.
