5 AN ORDINANCE APPROPRIATING \$60,000, INCLUDING
6 \$10,000 TO SIGMA BETA CLUB OF JACKSONVILLE INC.,
7 \$10,000 TO DELTA SIGMA THETA SORORITY, INC.,
8 JACKSONVILLE ALUMNAE CHAPTER, \$10,000 TO KAPPA
9 ALPHA PSI JACKSONVILLE FOUNDATION,
10 INCORPORATED, \$10,000 TO BETA ALPHA ZETA CHAPTER
11 OF ZETA PHI BETA SORORITY, INC., \$10,000 TO
12 OMEGAS 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI
13 PHI THETA PHI CHAPTER, INC.), AND \$10,000 TO
14 ALPHA-JAX FOUNDATION, INC. (GAMMA RHO OMEGA
15 CHAPTER, INC. OF ALPHA KAPPA ALPHA SORORITY),
16 FROM DESIGNATED CONTINGENCY ACCOUNTS WITHIN THE
17 GENERAL FUND TO THE PRIVATE ORGANIZATIONS
18 ACCOUNT WITHIN THE KIDS HOPE ALLIANCE ("KHA")
19 FUND TO PROVIDE FUNDING FOR VARIOUS YOUTH
20 PROGRAMS AND SERVICES (THE "PROGRAMS") AS
21 DESCRIBED HEREIN; AMENDING THE FOURTH REVISED
22 SCHEDULE M TO ORDINANCE 2023-511-E; INVOKING THE
23 EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS),
24 PART 1 (GENERAL REGULATIONS), CHAPTER 126
25 (PROCUREMENT CODE), *ORDINANCE CODE*, TO ALLOW FOR
26 DIRECT CONTRACTS WITH SIGMA BETA CLUB OF
27 JACKSONVILLE INC., DELTA SIGMA THETA SORORITY,
28 INC., JACKSONVILLE ALUMNAE CHAPTER, KAPPA ALPHA
29 PSI JACKSONVILLE FOUNDATION, INCORPORATED, BETA
30 ALPHA ZETA CHAPTER OF ZETA PHI BETA SORORITY,
31 INC., OMEGAS 4 CHANGE, INC. (AFFILIATE OF OMEGA

1 PSI PHI THETA PHI CHAPTER, INC.), AND ALPHA-JAX
2 FOUNDATION, INC. (GAMMA RHO OMEGA CHAPTER, INC.
3 OF ALPHA KAPPA ALPHA SORORITY) FOR THE PROGRAMS;
4 WAIVING THE REQUIREMENTS OF SECTION 77.111(A)
5 (PROVIDER CONTRACTS), CHAPTER 77 (KIDS HOPE
6 ALLIANCE), ORDINANCE CODE, TO EXEMPT THE
7 SERVICES TO BE PROVIDED BY THE AFOREMENTIONED
8 ORGANIZATIONS FROM COMPETITIVE PROCUREMENT;
9 APPROVING, AND AUTHORIZING THE MAYOR, OR HER
10 DESIGNEE, AND CORPORATION SECRETARY, AND/OR THE
11 CHIEF EXECUTIVE OFFICER OF KHA TO EXECUTE AND
12 DELIVER, AN AGREEMENT BETWEEN THE CITY AND SIGMA
13 BETA CLUB OF JACKSONVILLE INC., DELTA SIGMA
14 THETA SORORITY, INC., JACKSONVILLE ALUMNAE
15 CHAPTER, KAPPA ALPHA PSI JACKSONVILLE
16 FOUNDATION, INCORPORATED, BETA ALPHA ZETA
17 CHAPTER OF ZETA PHI BETA SORORITY, INC., OMEGAS
18 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI PHI THETA
19 PHI CHAPTER, INC.), AND ALPHA-JAX FOUNDATION,
20 INC. (GAMMA RHO OMEGA CHAPTER, INC. OF ALPHA
21 KAPPA ALPHA SORORITY) FOR THE PROGRAMS;
22 PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN
23 EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
27 within the City's budget, there is hereby appropriated the indicated
28 sum(s) from the account(s) listed in subsection (a) to the account(s)
29 listed in subsection (b):

5 (c) Explanation of Appropriation:

6 The funding above is an appropriation of \$60,000 from
7 Designated Contingency accounts within the General Fund to
8 the Subsidies and Contributions to Private Organizations
9 account within the Kids Hope Alliance ("KHA") Fund to
10 provide funding for various youth programs and services as
11 described herein, to include \$10,000 to Sigma Beta Club of
12 Jacksonville Inc., \$10,000 to Delta Sigma Theta Sorority,
13 Inc., Jacksonville Alumnae Chapter, \$10,000 to Kappa Alpha
14 Psi Jacksonville Foundation, Incorporated, \$10,000 to Beta
15 Alpha Zeta Chapter of Zeta Phi Beta Sorority, Inc., \$10,000
16 to Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta
17 Phi Chapter, Inc.), and \$10,000 to Alpha-Jax Foundation,
18 Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha
19 Sorority).

20 **Section 2. Purpose.** The purpose of the appropriation in
21 Section 1 is to provide funding from the City of Jacksonville to
22 Sigma Beta Club of Jacksonville Inc., Delta Sigma Theta Sorority,
23 Inc., Jacksonville Alumnae Chapter, Kappa Alpha Psi Jacksonville
24 Foundation, Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta
25 Sorority, Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi
26 Theta Phi Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho
27 Omega Chapter, Inc. of Alpha Kappa Alpha Sorority), for the provision
28 of youth programs and services in Duval County as more particularly
29 described in the Term Sheets attached hereto as **Exhibit 2** and
30 incorporated herein by this reference (the "Programs"). The Programs
31 are designed to encourage youth participants to engage in leadership

1 opportunities and to pursue higher education. Several of the Programs
2 will use the City funding to provide expanded scholarship
3 opportunities to eligible students who pursue higher education. In
4 addition, several of the Programs will use the City funding to cover
5 the costs for students and youth who desire to attend education and
6 leadership conferences and/or trips to visit colleges and
7 universities that are sponsored by the recipient organizations.

8 **Section 3. Amending Fourth Revised Schedule M to Ordinance**
9 **2023-511-E.** The Kids Hope Alliance fiscal year 2023-2024 budget
10 approved by Ordinance 2023-511-E is hereby amended by substituting
11 in the place of the Fourth Revised Schedule M, the Fifth Revised
12 Schedule M, attached hereto as **Exhibit 3** and incorporated herein by
13 this reference. The Fifth Revised Schedule M reflects the funds
14 appropriated herein.

15 **Section 4. Invoking the Exemption in Section 126.107(g),**
16 **Ordinance Code.** The City is hereby authorized to directly procure
17 the professional services of Sigma Beta Club of Jacksonville Inc.,
18 Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae Chapter, Kappa
19 Alpha Psi Jacksonville Foundation, Incorporated, Beta Alpha Zeta
20 Chapter of Zeta Phi Beta Sorority, Inc., Omegas 4 Change, Inc.
21 (affiliate of Omega Psi Phi Theta Phi Chapter, Inc.), and Alpha-Jax
22 Foundation, Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha
23 Sorority), for the provision of youth programs and services. Pursuant
24 to Section 126.107(g) (Exemptions), Part 1 (General Regulations),
25 Chapter 126 (Procurement Code), *Ordinance Code*, such procurement is
26 exempted from competitive solicitation because the supplies or
27 services are to be provided by those specifically prescribed within
28 authorizing legislation that appropriates the same. With the
29 exception of the foregoing, all other provisions of Chapter 126,
30 *Ordinance Code*, shall remain in full force and effect.

31 **Section 5. Waiving the Requirements of Section 77.111(a),**

1 **Ordinance Code.** The City hereby waives the requirements of Section
2 77.111(a) (Provider Contracts), Chapter 77 (Kids Hope Alliance),
3 *Ordinance Code*, with respect to the contracts with Sigma Beta Club
4 of Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville
5 Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation,
6 Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority,
7 Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi
8 Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega
9 Chapter, Inc. of Alpha Kappa Alpha Sorority), approved and authorized
10 by this Ordinance. Section 77.111(a) requires contracts for
11 children's services provided by third parties to be competitively
12 procured by KHA via an evaluated bid process. This waiver is needed
13 in order to allow KHA to directly contract with Sigma Beta Club of
14 Jacksonville Inc., Delta Sigma Theta Sorority, Inc., Jacksonville
15 Alumnae Chapter, Kappa Alpha Psi Jacksonville Foundation,
16 Incorporated, Beta Alpha Zeta Chapter of Zeta Phi Beta Sorority,
17 Inc., Omegas 4 Change, Inc. (affiliate of Omega Psi Phi Theta Phi
18 Chapter, Inc.), and Alpha-Jax Foundation, Inc. (Gamma Rho Omega
19 Chapter, Inc. of Alpha Kappa Alpha Sorority), to provide the youth
20 programs and services described in **Exhibit 2**.

21 **Section 6. Approval and Authorization to Execute**
22 **Agreements.** There is hereby approved, and the Mayor, or her designee,
23 and the Corporation Secretary, and/or the Chief Executive Officer of
24 KHA, are hereby authorized to execute and deliver on behalf of the
25 City, agreements with the following entities for the specified
26 not-to-exceed amounts: Sigma Beta Club of Jacksonville Inc.
27 (\$10,000), Delta Sigma Theta Sorority, Inc., Jacksonville Alumnae
28 Chapter (\$10,000), Kappa Alpha Psi Jacksonville Foundation,
29 Incorporated (\$10,000), Beta Alpha Zeta Chapter of Zeta Phi Beta
30 Sorority, Inc. (\$10,000), Omegas 4 Change, Inc. (affiliate of Omega
31 Psi Phi Theta Phi Chapter, Inc.) (\$10,000), and Alpha-Jax Foundation,

1 Inc. (Gamma Rho Omega Chapter, Inc. of Alpha Kappa Alpha Sorority)
2 (\$10,000), subject to the Term Sheet for each organization attached
3 hereto as **Exhibit 2**, for a term commencing on October 1, 2023 through
4 September 30, 2024, and all other contracts and documents, including
5 extensions, renewals and amendments to the agreements, and to
6 otherwise take all action necessary to effectuate the intent of this
7 Ordinance, subject to appropriate legal review and approval by the
8 Office of General Counsel and the City's Risk Management Division for
9 appropriate insurance and indemnification requirements in accordance
10 with Section 128.601, *Ordinance Code*.

11 **Section 7. Oversight Department.** The Kids Hope
12 Alliance shall oversee the programs described herein.

13 **Section 8. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
