7 A RESOLUTION CONFIRMING THE APPOINTMENT OF
8 ALANNA LUKSHA, A DUVAL COUNTY RESIDENT, AS A
9 MEMBER OF THE CULTURAL SERVICE GRANT PROGRAM
10 COMMITTEE, AS ONE OF SEVEN COMMUNITY
11 REPRESENTATIVES, REPLACING SALLY PETTEGREW,
12 PURSUANT TO SECTION 118.605, *ORDINANCE CODE*, FOR
13 A PARTIAL TERM EXPIRING DECEMBER 31, 2025;
14 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
15 PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, pursuant to Section 118.605(a), *Ordinance Code*, the
18 membership of the Cultural Service Grant Program (CSGP) Committee
19 shall include one non-voting and ten voting members: a CSGP Committee
20 chairperson (non-voting), appointed by the President of the Cultural
21 Council Board of Directors; three other Cultural Council Board members
22 selected by the Board President and Committee Chairperson; and seven
23 individuals selected by the above group (Cultural Council Board
24 President, CSGP Committee chairperson, and three selected Cultural
25 Council Board members) from a pool of nominations established through
26 a community wide nomination process; and

27 **WHEREAS**, pursuant to Section 118.605(d), *Ordinance Code*, all
28 members of the Cultural Service Grant Program Committee shall be
29 confirmed by the City Council; now therefore

30 **BE IT RESOLVED** by the Council of the City of Jacksonville:

31 **Section 1. Confirmation of Appointment.** The City Council

1 hereby confirms the Cultural Council of Greater Jacksonville's
2 appointment of Alanna Luksha, a Duval County resident, to the Cultural
3 Service Grant Program Committee, replacing Sally Pettegrew, as one
4 of seven community representatives, pursuant to Section 118.605,
5 *Ordinance Code*, for a partial term expiring December 31, 2025.

6 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
7 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
8 legislation is requested to enable the appointee to be seated in time
9 to participate in the Cultural Service Grant Program Committee's
10 Capital Grants review process in February.

11 **Section 3. Effective Date.** This Resolution shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
