6 AN ORDINANCE APPROVING TEMPORARY AND PERMANENT  
7 CHANGES IN POLLING PLACE LOCATIONS, AND BOUNDARY  
8 CHANGES WITHIN VARIOUS PRECINCTS, TO BE  
9 EFFECTIVE FOR THE 2026 PRIMARY ELECTION TO BE  
10 HELD AUGUST 18, 2026, IN THE CITY OF  
11 JACKSONVILLE, DUVAL COUNTY, FLORIDA, AS  
12 REQUESTED BY THE SUPERVISOR OF ELECTIONS  
13 PURSUANT TO SECTION 352.102, *ORDINANCE CODE*;  
14 PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Polling Place Location Changes Approved.** At the  
18 request of the Supervisor of Elections for Duval County, and pursuant  
19 to Section 352.102, *Ordinance Code*, the Council, acting as the  
20 governing body for Duval County, hereby approves a temporary change  
21 in polling place location for Precincts 208 and 604, and a permanent  
22 change in polling place location for Precincts 105, 211, 307, 508,  
23 811, 1104, 1105 and 1405, as outlined and attached hereto in **Exhibit**  
24 **1** respectively, to be effective immediately. The Supervisor of  
25 Elections and the Council Secretary are hereby authorized and directed  
26 to include these polling place locations in the Polling Place List  
27 on file in their respective offices.

28 **Section 2. Precinct Boundary Changes Approved.** At the  
29 request of the Supervisor of Elections for Duval County, and pursuant  
30 to Section 352.102, *Ordinance Code*, the Council, acting as the  
31 governing body for Duval County, hereby approves the boundary changes

1 with respect to the following Precincts: 1104, 1401, 1406 and 1408,  
2 as outlined and attached hereto in **Exhibit 2** respectively, to be  
3 effective immediately. The Supervisor of Elections and the Council  
4 Secretary are hereby authorized and directed to include these polling  
5 place locations in the Polling Place List on file in their respective  
6 offices.

7 **Section 3. Effective Date.** This Ordinance shall become  
8 effective upon signature by the Mayor or upon becoming effective  
9 without the Mayor's signature.
