5 AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT
6 OF PALECIA CRAWFORD-MADDOX, A DUVAL COUNTY
7 RESIDENT, REPLACING LEOLA WILLIAMS, AS A CITIZEN
8 MEMBER THAT LIVES WITHIN ONE MILE OF THE CRA
9 BOUNDARY REPRESENTING THE GENERAL PUBLIC,
10 PURSUANT TO SECTION 53.202 (MEMBERSHIP;
11 APPOINTMENT AND REMOVAL; TERMS OF OFFICE), PART
12 2 (KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT
13 AGENCY ADVISORY BOARD), CHAPTER 53 (COMMUNITY
14 REDEVELOPMENT AGENCY ADVISORY BOARDS),
15 *ORDINANCE CODE*, FOR A FIRST FULL TERM TO EXPIRE
16 ON DECEMBER 31, 2025; WAIVING SECTION 53.202
17 (MEMBERSHIP; APPOINTMENT AND REMOVAL; TERMS OF
18 OFFICE), PART 2 (KINGSOUTEL CROSSING COMMUNITY
19 REDEVELOPMENT AGENCY ADVISORY BOARD), CHAPTER 53
20 (COMMUNITY REDEVELOPMENT AGENCY ADVISORY
21 BOARDS) TO ALLOW APPOINTMENT OF A CITIZEN WHO
22 DOES NOT LIVE WITHIN ONE MILE OF THE CRA
23 BOUNDARY; PROVIDING AN EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appointment.** The Council hereby confirms the
27 Mayor's appointment of Palecia Crawford-Maddox, a Duval County
28 resident, replacing Leola Williams, to the KingSoutel Crossing
29 Community Redevelopment Agency Advisory Board, as a citizen member
30 that lives within one mile of the CRA boundary representing the
31 general public, pursuant to section 53.202 (Membership; appointment

1 and removal; terms of office), Part 2 (KingSoutel Crossing Community
2 Redevelopment Agency Advisory Board), Chapter 53 (Community
3 Redevelopment Agency Advisory Boards), *Ordinance Code*, for a first
4 full term to expire on December 31, 2025.

5 **Section 2. Waiving Section 53.202 (Membership; appointment**
6 **and removal; terms of office), Part 2 (KingSoutel Crossing Community**
7 **Redevelopment Agency Advisory Board), Chapter 53 (Community**
8 **Redevelopment Agency Advisory Boards), *Ordinance Code*.** The
9 provisions of Section 53.202 (Membership; appointment and removal;
10 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment
11 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency
12 Advisory Boards), *Ordinance Code*, are hereby waived to allow for Ms.
13 Crawford-Maddox's appointment even though she does not live within
14 one mile of the CRA boundary. The City finds that Ms. Crawford-Maddox
15 has acquired significant experience within the Northside community
16 which would be beneficial to the Advisory Board and City.

17 **Section 3. Effective Date.** This ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
