8 A FINANCE ORGANIZATION REPRESENTATIVE,
9 REPLACING JEFFREY ROSEN, IN ACCORDANCE WITH
10 SECTION 52.106 (MEMBERSHIP; TERMS; REMOVAL;
11 VACANCY; ETC), CHAPTER 52 (JACKSONVILLE HOUSING
12 FINANCE AUTHORITY), *ORDINANCE CODE*, FOR A FIRST
13 FULL TERM EXPIRING ON JUNE 30, 2029; PROVIDING
14 FOR A DIRECTIVE FOR THE CHIEF OF LEGISLATIVE
15 SERVICES; PROVIDING AN EFFECTIVE DATE.

17 **BE IT RESOLVED** by the Council of the City of Jacksonville:

18 **Section 1. Appointment.** The Council hereby confirms the
19 Mayor's appointment of Kristen K. Packard, a Duval County resident,
20 to the Jacksonville Housing Finance Authority as a finance
21 organization representative, replacing Jeffrey Rosen, in accordance
22 with Section 52.106 (Membership; terms; removal; vacancy; etc.),
23 Chapter 52 (Jacksonville Housing Finance Authority), *Ordinance Code*,
24 for a first full term expiring on June 30, 2029.

25 **Section 2. Directive for the Chief of Legislative Services.**
26 Pursuant to Section 52.106(a), *Ordinance Code*, a certified copy of
27 the appointment or reappointment upon adoption for the Jacksonville
28 Housing Finance Authority shall be filed with the Clerk of the Circuit
29 Court of the County, and the certificate shall be conclusive evidence
30 of the due and proper appointment of the member. The Chief of
31 Legislative Services is hereby directed to forward a certified copy

1 of this appointment to the Jacksonville Housing Finance Authority.

2 **Section 3. Effective Date.** This Resolution shall become
3 effective upon signature by the Mayor or upon becoming effective
4 without the Mayor's signature.
