**ORDINANCE 2025-405**

AN ORDINANCE AUTHORIZING THE GRANTING OF A  
NON-RESIDENTIAL SOLID WASTE COLLECTION AND  
TRANSPORTATION FRANCHISE TO CWR COMMONWEALTH  
REFUSE, LLC PURSUANT TO PART 6  
(NONRESIDENTIAL SOLID WASTE COLLECTION AND  
TRANSPORTATION FRANCHISES), CHAPTER 380  
(SOLID WASTE MANAGEMENT), *JACKSONVILLE  
ORDINANCE CODE*; PROVIDING FOR OVERSIGHT BY  
THE OFFICE OF ADMINISTRATIVE SERVICES, SOLID  
WASTE DIVISION; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, CWR Commonwealth Refuse, LLC ("CWR") has submitted an  
application for a non-residential solid waste collection and  
transportation franchise pursuant to the provisions of Chapter 380,  
Part 6, *Jacksonville Ordinance Code*; and

**WHEREAS**, the application was reviewed by the Solid Waste  
Division of the Office of Administrative Services; and

**WHEREAS**, the Office of Administrative Services recommends  
granting a franchise for non-residential solid waste collection and  
transportation to CWR; and

**WHEREAS**, granting a non-residential solid waste collection and  
transportation franchise to CWR will further the purpose for which  
the franchise program was adopted, including, but not limited to,  
safeguarding public health, safety and welfare in the collection and  
transportation of solid waste through Jacksonville; now therefore

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1. Franchise Agreement authorized.** In accordance

1 with the provisions of Part 6 (Nonresidential Solid Waste Collection  
2 and Transportation Franchises), Chapter 380 (Solid Waste Management),  
3 *Jacksonville Ordinance Code*, the Manager of the Office of  
4 Administrative Services is hereby authorized to issue a franchise  
5 agreement to CWR Commonwealth Refuse, LLC for collection and  
6 transportation of non-residential solid waste in the City of  
7 Jacksonville. CWR has paid the application fee of \$1,500.00. A copy  
8 of the Non-Residential Solid Waste Collection and Transportation  
9 Franchise Agreement is attached hereto as **Exhibit 1** and incorporated  
10 herein by this reference. A copy of the letter from the Office of  
11 Administrative Services forwarding CWR's application to the Council  
12 for action is attached hereto as **Exhibit 2** and incorporated herein  
13 by this reference.

14 **Section 2. Oversight.** The Solid Waste Division of the  
15 Office of Administrative Services shall oversee the franchise  
16 described herein.

17 **Section 3. Effective Date.** This Ordinance shall become  
18 effective upon signature by the Mayor or upon becoming effective  
19 without the Mayor's signature.
