7 AN ORDINANCE CONCERNING SURPLUS PERSONAL
8 PROPERTY OF THE CITY; DECLARING THAT CERTAIN
9 2001 CHEVROLET G3500 VAN (VIN
10 1GAHG39R411167225, VEHICLE NUMBER 8056-10)
11 VALUED AT \$5,625 TO BE SURPLUS TO THE NEEDS OF
12 THE CITY AND AUTHORIZING THE APPROPRIATE
13 OFFICIALS OF THE CITY TO TRANSFER TITLE OF
14 SAID PROPERTY TO FAMILIES OF SLAIN CHILDREN OF
15 JACKSONVILLE, FLORIDA, INC. FOR USE AS A
16 TRANSPORT VEHICLE TO AID IN PROVIDING
17 TRANSPORTATION TO ASSIST KIDS TO AND FROM
18 PROGRAMS AS WELL AS SCHEDULED TRIPS, AT NO
19 COST, IN ACCORDANCE WITH SECTION 122.812(C),
20 *ORDINANCE CODE*; DESIGNATING THE FLEET
21 MANAGEMENT DIVISION OF THE FINANCE AND
22 ADMINISTRATION DEPARTMENT TO MONITOR ACTUAL
23 USE OF SAID PROPERTY; PROVIDING FOR A
24 REVERTER; AUTHORIZING THE MAYOR OR HIS
25 DESIGNEE AND THE CORPORATE SECRETARY TO
26 EXECUTE AN AGREEMENT FOR SURPLUSSING OF CITY
27 PERSONAL PROPERTY BETWEEN THE CITY OF
28 JACKSONVILLE AND FAMILIES OF SLAIN CHILDREN OF
29 JACKSONVILLE, FLORIDA, INC.; PROVIDING AN
30 EFFECTIVE DATE.

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Declaration of Surplus.** The City hereby
3 declares that certain 2001 Chevrolet G3500 Van (VIN
4 1GAHG39R411167225, vehicle number 8056-10) valued at \$5,625, as
5 more particularly described in **Exhibit 1** attached hereto and
6 incorporated herein by this reference ("Subject Property"), to be
7 surplus to the needs of the City of Jacksonville and authorizes the
8 appropriate City officials to transfer title of the Subject
9 Property to Families of Slain Children of Jacksonville, Florida,
10 Inc. at no cost, pursuant to Section 122.812(c), *Ordinance Code*. A
11 copy of the certificate from the Director of Procurement certifying
12 compliance with provisions of Chapter 122, *Ordinance Code*, is
13 attached hereto as **Exhibit 2**, and incorporated herein by this
14 reference. A copy of the property transfer forms is attached
15 hereto as **Exhibit 3**.

16 **Section 2. Public Purpose.** The surplus vehicle is needed
17 by Families of Slain Children of Jacksonville, Florida, Inc. to be
18 used as a transport vehicle to aid in providing transportation to
19 assist kids to and from our programs as well as scheduled trips.
20 The City of Jacksonville finds that providing the surplussed
21 vehicle to Families of Slain Children of Jacksonville, Florida,
22 Inc. for a transport vehicle to aid in providing transportation to
23 assist kids to and from our programs as well as scheduled trips, is
24 a valid public purpose.

25 **Section 3. Fleet Management Division to Monitor Actual**
26 **Use of Subject Property.** The Fleet Management Division of the
27 Finance and Administration Department will be the designated agency
28 to monitor Families of Slain Children of Jacksonville, Florida,
29 Inc.'s use of the Subject Property in accordance with the purposes
30 set forth herein.

31 **Section 4. Reverter.** The disposition authorized herein

1 is conditioned upon Families of Slain Children of Jacksonville,
2 Florida, Inc. using the said vehicle for the purposes set forth
3 herein and is conditioned upon Families of Slain Children of
4 Jacksonville, Florida, Inc. agreeing to convey the vehicle back to
5 the City of Jacksonville in the event that the vehicle is not used
6 for those purposes.

7 **Section 5. Approval and Authorization.** he Mayor, his
8 designee and Corporation Secretary are hereby authorized to execute
9 an Agreement for the surplussing of City personal property between
10 the City of Jacksonville and Families of Slain Children of
11 Jacksonville, Florida, Inc., attached hereto as **Exhibit 4**, and
12 incorporated herein by this reference.

13 **Section 6. Effective Date.** This ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
