21 **BE IT RESOLVED** by the Council of the City of Jacksonville:

22 **Section 1. Appointment.** The Council hereby confirms the
23 Mayor's appointment of Leroy Kelly, a Duval County resident, replacing
24 Palecia Crawford-Maddox, to the KingSoutel Crossing Community
25 Redevelopment Agency Advisory Board, as a citizen member that lives
26 within one mile of the CRA boundary representing the general public,
27 pursuant to section 53.202 (Membership; appointment and removal;
28 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment
29 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency
30 Advisory Boards), *Ordinance Code*, for a partial term to expire on
31 December 31, 2025, followed by a first full term to expire on December

31, 2029.

Section 2. Effective Date. This resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
