

BUSINESS IMPACT ESTIMATE

ORDINANCE 2026-138

AN ORDINANCE ESTABLISHING THE FISCAL YEAR 2026-2027 CATEGORIES OF MOST VULNERABLE PERSONS AND NEEDS FOR PUBLIC SERVICE GRANT APPROPRIATIONS IN ACCORDANCE WITH CHAPTER 118 (CITY GRANTS), ORDINANCE CODE; PROVIDING AN EFFECTIVE DATE.

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare):

This Ordinance establishes the categories of Most Vulnerable Persons and Needs and the percentages of funding to be allocated to each category out of the City's total Public Service Grants appropriation for Fiscal Year 2026-2027. Public service grants are awarded to non-profit organizations providing services and programs to some of the City's most vulnerable populations. These programs and services give individuals within these populations access to basic necessities and services aimed at improving their overall health and wellbeing.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the City of Jacksonville, if any:

- (a) An estimate of direct compliance costs that businesses may reasonably incur;
- (b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible; and
