4 **ORDINANCE 2022-325-E**

5 AN ORDINANCE REGARDING THE DUVAL COUNTY PROPERTY
6 APPRAISER'S BUDGET FOR FISCAL YEAR 2022-2023;
7 ADOPTING RECOMMENDED FINDINGS AND CONCLUSIONS
8 FOR THE DUVAL COUNTY PROPERTY APPRAISER'S 2022-
9 2023 FISCAL YEAR BUDGET; PROVIDING AN EFFECTIVE
10 DATE.

12 **WHEREAS**, pursuant to Section 195.087, *Florida Statutes*, the
13 Duval County Property Appraiser's Office ("Property Appraiser")
14 submits its budget annually to the Department of Revenue on or before
15 June 1; and

16 **WHEREAS**, pursuant to Section 106.201, *Ordinance Code*, the Mayor
17 is required to submit the final annual Consolidated City of
18 Jacksonville budget proposal, which includes the Property Appraiser's
19 budget, to the City Council no later than the first City Council
20 Committee meeting in July; and

21 **WHEREAS**, during the weeks following the first City Council
22 Committee meeting in July, the City Council Finance Committee reviews
23 the budgets of the Property Appraiser along with the entire
24 consolidated government as is required by Section 5.07 of the City
25 of Jacksonville Charter; and

26 **WHEREAS**, therefore the review of the Property Appraiser's budget
27 is simultaneously occurring with the Department of Revenue and the
28 City of Jacksonville; and

29 **WHEREAS**, although there is a provision for the Department of
30 Revenue to include the City of Jacksonville's modifications to the
31 Property Appraiser's budget, that information must be received from

1 the City Council, acting as the whole Council, prior to the Florida
2 Department of Revenue tentatively approving the Property Appraiser's
3 budget, or alternatively subject to an appeal process; and

4 **WHEREAS**, the City Council recognizes this schedule and desires
5 to review the Property Appraiser's budget as will be presented to the
6 Department of Revenue in advance of the Mayor's annual budget
7 proposal; now therefore

8 **BE IT ORDAINED** by the Council for the City of Jacksonville:

9 **Section 1. Property Appraiser's Budget Review.** The City
10 Council is in receipt of the Fiscal Year 2022-2023 Property
11 Appraiser's budget which is attached hereto as **Exhibit 1**.

12 **Section 2. Adoption of recommended findings and**
13 **conclusions.** The Council has reviewed the Property Appraiser's
14 budget along with the input and recommendations from the Finance and
15 Administration Department and Chief Administrative Officer of the
16 Mayor. The recommended findings and conclusions are hereby adopted
17 and shall be forwarded to the Department of Revenue to be considered
18 by same in tentatively approving the Duval County Property Appraiser's
19 2022-2023 fiscal year budget.

20 **Section 3. Effective Date.** This ordinance shall become
21 effective upon the signature by the Mayor or upon becoming effective
22 without the Mayor's signature.
