AN ORDINANCE RESCHEDULING THE FINANCE COMMITTEE, TRANSPORTATION, ENERGY AND UTILITIES (TEU) COMMITTEE, AND LAND USE AND ZONING (LUZ) COMMITTEE MEETINGS OF TUESDAY, NOVEMBER 5, 2024, TO WEDNESDAY, NOVEMBER 6, 2024; DIRECTING APPROPRIATE NOTIFICATION BY THE CHIEF OF THE LEGISLATIVE SERVICES DIVISION; WAIVING COUNCIL 2.201 AUTHORIZE RULE (MEETINGS) TO RESCHEDULING; REQUESTING EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Council Rule 2.201 (Meetings) provides for Standing Committee meetings to be held during the first and third weeks of every month (except for the first week in July and the third week in December); and

WHEREAS, pursuant to Council Rule 2.201 (Meetings), the Council President has set the regular meetings of the Finance Committee, Transportation, Energy and Utilities (TEU) Committee, and Land Use and Zoning (LUZ) Committee for the first and third Tuesdays of each month (except for the first week in July and the third week in December); and

WHEREAS, the Finance Committee, TEU Committee, and LUZ Committee are scheduled to meet on Tuesday, November 5, 2024, which is the date of the 2024 General Election; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Finance Committee, Transportation, Energy and Utilities Committee, and Land Use and Zoning Committee Meetings on

Tuesday, November 5, 2024, Rescheduled. The Finance Committee, Transportation Energy and Utilities Committee, and Land Use and Zoning Committee meetings scheduled for Tuesday, November 5, 2024, in the Council Chambers are hereby rescheduled to Wednesday, November 6, 2024, in the Council Chamber. The Land Use and Zoning Committee agenda meeting is also hereby rescheduled to Wednesday, November 6, 2024, at 4:30 p.m. in Council Chamber.

Section 2. Notification. The Chief of Legislative Services is hereby directed to ensure that all public hearings are advertised and scheduled for Wednesday, November 6, 2024, and to ensure that any other notifications necessary to conduct the Finance, TEU, and LUZ Committee meetings and LUZ Committee agenda meeting on Wednesday, November 6, 2024, are made.

Section 3. Council Rule 2.201 (Meetings) Waived. Pursuant to Council Rule 2.201 (Meetings), the Council President has set the regular meetings of the Finance Committee, TEU Committee, and LUZ Committee for the first and third Tuesdays of each month (except for the first week in July and the third week in December).
