5 AN ORDINANCE RESCHEDULING THE FINANCE COMMITTEE,
6 TRANSPORTATION, ENERGY AND UTILITIES (TEU)
7 COMMITTEE, AND LAND USE AND ZONING (LUZ)
8 COMMITTEE MEETINGS OF TUESDAY, NOVEMBER 5, 2024,
9 TO WEDNESDAY, NOVEMBER 6, 2024; DIRECTING
10 APPROPRIATE NOTIFICATION BY THE CHIEF OF THE
11 LEGISLATIVE SERVICES DIVISION; WAIVING COUNCIL
12 RULE 2.201 (MEETINGS) TO AUTHORIZE THE
13 RESCHEDULING; REQUESTING EMERGENCY PASSAGE UPON
14 INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, Council Rule 2.201 (Meetings) provides for Standing
17 Committee meetings to be held during the first and third weeks of
18 every month (except for the first week in July and the third week in
19 December); and

20 **WHEREAS**, pursuant to Council Rule 2.201 (Meetings), the
21 Council President has set the regular meetings of the Finance
22 Committee, Transportation, Energy and Utilities (TEU) Committee, and
23 Land Use and Zoning (LUZ) Committee for the first and third Tuesdays
24 of each month (except for the first week in July and the third week
25 in December); and

26 **WHEREAS**, the Finance Committee, TEU Committee, and LUZ
27 Committee are scheduled to meet on Tuesday, November 5, 2024, which
28 is the date of the 2024 General Election; now therefore

29 **BE IT ORDAINED** by the Council of the City of Jacksonville:

30 **Section 1. Finance Committee, Transportation, Energy and**
31 **Utilities Committee, and Land Use and Zoning Committee Meetings on**

1 **Tuesday, November 5, 2024, Rescheduled.** The Finance Committee,
2 Transportation Energy and Utilities Committee, and Land Use and Zoning
3 Committee meetings scheduled for Tuesday, November 5, 2024, in the
4 Council Chambers are hereby rescheduled to Wednesday, November 6,
5 2024, in the Council Chamber. The Land Use and Zoning Committee agenda
6 meeting is also hereby rescheduled to Wednesday, November 6, 2024,
7 at 4:30 p.m. in Council Chamber.

8 **Section 2. Notification.** The Chief of Legislative Services
9 is hereby directed to ensure that all public hearings are advertised
10 and scheduled for Wednesday, November 6, 2024, and to ensure that any
11 other notifications necessary to conduct the Finance, TEU, and LUZ
12 Committee meetings and LUZ Committee agenda meeting on Wednesday,
13 November 6, 2024, are made.

14 **Section 3. Council Rule 2.201 (Meetings) Waived.** Pursuant
15 to Council Rule 2.201 (Meetings), the Council President has set the
16 regular meetings of the Finance Committee, TEU Committee, and LUZ
17 Committee for the first and third Tuesdays of each month (except for
18 the first week in July and the third week in December). Council Rule
19 2.201 (Meetings) is hereby waived to authorize the rescheduling of
20 the Finance Committee, TEU Committee, and LUZ Committee meetings as
21 stated herein.

22 **Section 4. Requesting Emergency Passage Upon Introduction**
23 **Pursuant to Council Rule 4.901.** Emergency passage of this legislation
24 upon introduction is requested to ensure City staff has time to
25 prepare and issue revised notices and advertisements for the Committee
26 meetings and associated public hearings, as applicable, to provide
27 as much advance notice to the public and other affected parties as
28 possible.

29 **Section 5. Effective Date.** This Ordinance shall
30 become effective upon signature by the Mayor or upon becoming
31 effective without the Mayor's signature.
