The funding above represents an appropriation of \$3,500,000.00 from the General Fund - Property Taxes account to General Fund - Subsidies and Contributions to Private Organizations.

Section 3. Purpose. The purpose of the appropriation in Section 2 is to appropriate funds to pay for costs associated with the operation and relocation of the Jacksonville University College of Law to a new facility including, but not limited to, any lease or loan payments associated with the facilities, staff payroll and overhead expenses, and professional expenses related to the design, occupancy, use, and operation of the new facility.

Section 4. Approval and Authorization to Execute an Agreement Between the City and Jacksonville University ("JU"). The Mayor, or her designee, and the Corporation Secretary are hereby authorized to negotiate, execute and deliver, for and on behalf of the City, a funding agreement with JU in an amount not-to-exceed

\$3,500,000 for the operation of the Jacksonville University College of Law to be relocated in downtown Jacksonville, consistent with the term sheet attached hereto as Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Term Sheet, March 18, 2024 - Rules" and incorporated herein by this reference, and all other contracts, memorandums of understanding and documents, including extensions, renewals or amendments thereto, and to otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the Office of General Counsel and the City's Management Division for appropriate insurance indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 5. Waiving Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code. The provisions of Section 118.107 (Nonprofits to receive funding through a competitive evaluated award process), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code, are hereby waived to allow for a direct contract between the City of Jacksonville and JU. JU is a non-profit organization and has established a new College of Law in downtown Jacksonville. The City finds that this direct contract is justified because JU intends to make a significant investment in downtown Jacksonville as it grows and moves to its new location and the College of Law will meet a pressing need for quality legal education in northeast Florida.

Section 6. Oversight Department. The Office of Economic Development shall oversee the Agreement and the project described herein.

Section 7. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
