7 AN ORDINANCE CONFIRMING THE MAYOR'S
8 REAPPOINTMENT OF RUSSELL JACKSON, A DUVAL COUNTY
9 RESIDENT, AS A CITIZEN MEMBER OF THE KINGSOUTEL
10 CROSSING COMMUNITY REDEVELOPMENT AGENCY
11 ADVISORY BOARD THAT LIVES WITHIN ONE MILE OF THE
12 CRA BOUNDARY REPRESENTING THE GENERAL PUBLIC,
13 PURSUANT TO SECTION 53.202 (MEMBERSHIP;
14 APPOINTMENT AND REMOVAL; TERMS OF OFFICE), PART
15 2 (KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT
16 AGENCY ADVISORY BOARD), CHAPTER 53 (COMMUNITY
17 REDEVELOPMENT AGENCY ADVISORY BOARDS),
18 *ORDINANCE CODE*, FOR A FIRST FULL TERM TO EXPIRE
19 ON DECEMBER 31, 2026; WAIVING SECTION 53.202
20 (MEMBERSHIP; APPOINTMENT AND REMOVAL; TERMS OF
21 OFFICE), PART 2 (KINGSOUTEL CROSSING COMMUNITY
22 REDEVELOPMENT AGENCY ADVISORY BOARD), CHAPTER 53
23 (COMMUNITY REDEVELOPMENT AGENCY ADVISORY
24 BOARDS), *ORDINANCE CODE*, TO ALLOW THE
25 APPOINTMENT OF A CITIZEN WHO DOES NOT PRESENTLY
26 LIVE WITHIN ONE MILE OF THE CRA BOUNDARY;
27 PROVIDING AN EFFECTIVE DATE.

29 **WHEREAS**, Ordinance 2019-446-A appointed Russell Jackson to the
30 KingSoutel Crossing Community Redevelopment Agency Advisory Board as
31 a citizen member that lives within one mile of the CRA Boundary

1 representing the general public; and

2 **WHEREAS**, at present he does not live within one mile of the
3 CRA Boundary; now therefore

4 **BE IT ORDAINED** by the Council of the City of Jacksonville:

5 **Section 1. Reappointment.** The Council hereby confirms the
6 Mayor's reappointment of Russell Jackson, a Duval County resident,
7 to the KingSoutel Crossing Community Redevelopment Agency Advisory
8 Board, as a citizen member that lives within one mile of the CRA
9 boundary representing the general public, pursuant to section 53.202
10 (Membership; appointment and removal; terms of office), Part 2
11 (KingSoutel Crossing Community Redevelopment Agency Advisory Board),
12 Chapter 53 (Community Redevelopment Agency Advisory Boards),
13 *Ordinance Code*, for a first full term to expire on December 31, 2026.

14 **Section 2. Waiving Section 53.202 (Membership; appointment**
15 **and removal; terms of office), Part 2 (KingSoutel Crossing Community**
16 **Redevelopment Agency Advisory Board), Chapter 53 (Community**
17 **Redevelopment Agency Advisory Boards), *Ordinance Code*.** The
18 provisions of Section 53.202 (Membership; appointment and removal;
19 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment
20 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency
21 Advisory Boards), *Ordinance Code*, are hereby waived to allow for Mr.
22 Jackson's appointment even though he does not at present live within
23 one mile of the CRA boundary. The City finds that Mr. Jackson has
24 held his current seat since July 23, 2019 and acquired significant
25 experience within the Northside community which would be beneficial
26 to the Advisory Board and City.

27 **Section 3. Effective Date.** This Ordinance shall become
28 effective upon signature by the Mayor or upon becoming effective
29 without the Mayor's signature.
