WHEREAS, Ordinance 2019-446-A appointed Russell Jackson to the KingSoutel Crossing Community Redevelopment Agency Advisory Board as a citizen member that lives within one mile of the CRA Boundary

representing the general public; and

WHEREAS, at present he does not live within one mile of the CRA Boundary; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Mayor's reappointment of Russell Jackson, a Duval County resident, to the KingSoutel Crossing Community Redevelopment Agency Advisory Board, as a citizen member that lives within one mile of the CRA boundary representing the general public, pursuant to section 53.202 (Membership; appointment and removal; terms of office), Part 2 (KingSoutel Crossing Community Redevelopment Agency Advisory Board), Chapter 53 (Community Redevelopment Agency Advisory Boards), Ordinance Code, for a first full term to expire on December 31, 2026.

Waiving Section 53.202 (Membership; appointment Section 2. and removal; terms of office), Part 2 (KingSoutel Crossing Community Agency Advisory Board), Chapter (Community Redevelopment 53 Redevelopment Agency Advisory Boards), Ordinance Code. The provisions of Section 53.202 (Membership; appointment and removal; terms of office), Part 2 (KingSoutel Crossing Community Redevelopment Agency Advisory Board), Chapter 53 (Community Redevelopment Agency Advisory Boards), Ordinance Code, are hereby waived to allow for Mr. Jackson's appointment even though he does not at present live within one mile of the CRA boundary. The City finds that Mr. Jackson has held his current seat since July 23, 2019 and acquired significant experience within the Northside community which would be beneficial to the Advisory Board and City.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
