22 **BE IT RESOLVED** by the Council of the City of Jacksonville:

23 **Section 1. Appointment.** The Council hereby confirms the
24 Mayor's appointment of Leroy Kelly, a Duval County resident, replacing
25 Palecia Crawford-Maddox, to the KingSoutel Crossing Community
26 Redevelopment Agency Advisory Board, as a citizen member that lives
27 within one mile of the CRA boundary representing the general public,
28 pursuant to section 53.202 (Membership; appointment and removal;
29 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment
30 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency
31 Advisory Boards), *Ordinance Code*, for a partial term to expire on

1 December 31, 2025, followed by a first full term to expire on December
2 31, 2029.

3 **Section 2. Effective Date.** This Resolution shall become
4 effective upon signature by the Mayor or upon becoming effective
5 without the Mayor's signature.
