5 A RESOLUTION HONORING THE LIFE OF KENNETH LLOYD
6 JOHNSON; HONORING MR. JOHNSON'S DEDICATION AS A
7 PUBLIC SERVANT AND VETERAN AND EXPRESSING THE
8 CITY COUNCIL'S DEEPEST CONDOLENCES TO HIS LOVED
9 ONES; PROVIDING AN EFFECTIVE DATE.

11 **WHEREAS**, on July 14, 2025, dedicated public servant and veteran
12 Kenneth Lloyd Johnson passed away; and

13 **WHEREAS**, born December 15, 1946, in Mt. Vernon, New York, to
14 parents Maceo Pierce Johnson, Sr. and Ella Louise Jackson Johns, Mr.
15 Johnson was educated in Jacksonville, Florida, where he graduated
16 from New Stanton High School in 1964 and Edward Waters College in
17 1968, where he pledged Omega Psi Phi, Chi Chapter; and

18 **WHEREAS**, Mr. Johnson, a Vietnam veteran, proudly served in the
19 United States Army, and his most recent role was that of Senior
20 Veterans Outreach Coordinator for the City of Jacksonville's Military
21 Affairs and Veterans Department; and

22 **WHEREAS**, Mr. Johnson's public service extended beyond his
23 military service, being one of the original Foundation Members of the
24 University of North Florida, serving in the Administrations of Mayors
25 Jake Godbold and Alvin Brown, and on the staff of the late Florida
26 Senator Betty Holzendorf and former United States Representative
27 Corrine Brown; and

28 **WHEREAS**, he is preceded by his parents, his brother, Leon Carlyle
29 Johnson, Sr., and niece Annie Josephine Bridgers, and he is survived
30 by his sister, Annie Josephine Bridgers; brothers, Maceo Pierce
31 Johnson, Jr. (Ida), David Christian Johnson, Sr. (Sandra), and

1 Theodore Wadsworth Johnson, Sr. (Laurie); nieces, Michelle Johnson
2 and Arin Johnson; nephews, Leon Johnson, Jr. (Annetta), Brawley
3 Bridgers (Gerri), Theodore Johnson, Jr., David Johnson, Jr. (Rita),
4 and Brandon Johnson; great-nephews, Daunte Johnson-Butler and Zion
5 Johnson-Jennings; caregiver and godson, Brent Wiggins; and a host of
6 cousins; and

7 **WHEREAS**, Kenneth Lloyd Johnson's life reflected a commitment to
8 our city and nation as evidenced by a lifelong commitment to public
9 service and community; now therefore
