5 AN ORDINANCE APPROPRIATING \$210,620.00 IN
6 ADDITIONAL STATE HOUSING INITIATIVES
7 PARTNERSHIP (SHIP) PROGRAM GRANT FUNDING FOR
8 FISCAL YEAR 2021-2022 FROM THE FLORIDA
9 DEPARTMENT OF ECONOMIC OPPORTUNITY THROUGH THE
10 FLORIDA HOUSING FINANCE CORPORATION TO SERVE
11 VERY LOW, LOW, AND MODERATE-INCOME FAMILIES,
12 AS INITIATED BY B.T. 22-105; PROVIDING FOR AN
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
17 within the City's budget, there is hereby appropriated the
18 indicated sum(s) from the account(s) listed in subsection (a) to
19 the account(s) listed in subsection (b):

26 (c) Explanation of Appropriation:

27 The funding above is an appropriation of \$210,620.00 in
28 additional State Housing Initiatives Partnership (SHIP)
29 Program grant funds from Florida Department of Economic
30 Opportunity through the Florida Housing Finance
31 Corporation for fiscal year 2021-2022.

1 **Section 2. Purpose.** The Florida Housing Finance
2 Corporation provides funding to local governments as an incentive
3 to create partnerships that produce and preserve affordable
4 homeownership and multifamily housing. The SHIP program was
5 designed to serve very low, low, and moderate-income families.
6 SHIP funds may be used for emergency repairs, new construction,
7 rehabilitation, down payment and closing costs assistance,
8 acquisition of property for affordable housing, matching dollars
9 for federal housing grants and programs, homeownership counseling
10 and the Foreclosure Intervention Program. The SHIP funds
11 appropriated herein will fund additional forgivable loans for the
12 City's Owner-Occupied Rehabilitation Program Project (\$10,620.00)
13 and the City's Rental Housing Development Project (\$200,000.00) for
14 development of additional affordable housing. A copy of the state
15 of Florida SHIP 2021-2022 Payment #4 disbursements reflecting these
16 additional funds for Duval County is attached hereto as **Exhibit 2.**

17 **Section 3. Effective Date.** This Ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
