## ORDINANCE 2024-41

AN ORDINANCE AMENDING SECTION 111.920 (HOMELESSNESS INITIATIVES SPECIAL REVENUE FUND), PART 9 (NEIGHBORHOOD DEVELOPMENT), CHAPTER 111 (SPECIAL REVENUE AND TRUST ACCOUNTS), ORDINANCE CODE, TO PROVIDE FOR FUNDING OF HOMELESSNESS INITIATIVES THROUGH CERTAIN ECONOMIC DEVELOPMENT AGREEMENT INCENTIVES; PROVIDING AN EFFECTIVE DATE.

purpose, such as serving the public health, safety, morals, and welfare): This Ordinance provides a funding mechnism for homelessness initiatives by requiring an amount equal to 4% of the total economic development agreement incentives approved by the City for development outside the CRAs in each calendar year to be deposited in the City's Homelessness Initiatives Special Revenue Fund. This serves the public health, safety and welfare by providing a funding source for programs, services and initiatives that address the needs of Duval County's homeless and chronic unhoused populations.
