8 JACKSONVILLE SMALL AND EMERGING BUSINESS PROGRAM
9 IN ACCORDANCE WITH SECTIONS 126.608 AND 126.609,
10 *ORDINANCE CODE*, AS INITIATED BY B.T. 21-120;
11 PURPOSE OF APPROPRIATION; PROVIDING FOR
12 CARRYOVER OF FUNDS INTO FISCAL YEAR 2021-2022;
13 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
14 PROVIDING AN EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
18 within the City's budget, there is hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The appropriation above is a transfer of General Fund debt
29 service interest savings in the amount of \$300,000.00 to
30 fund program support services for the Jacksonville Small
31 and Emerging Business Program (the "JSEB Program").

1 **Section 2. Purpose.** The purpose of the appropriation in
2 Section 1 is to procure consulting and supportive services for the
3 JSEB Program in accordance with Sections 126.608 and 126.609,
4 *Ordinance Code.* Specifically, these funds will be used to
5 competitively procure the professional services of consultants to
6 oversee and manage the Access to Capital and Bond Enhancement programs
7 administered as part of the City’s JSEB Program.

8 **Section 3. Carryover.** The funds appropriated in this
9 Ordinance shall not lapse but shall carryover to fiscal year 2021-
10 2022.

11 **Section 4. Requesting One Cycle Emergency Passage Pursuant**
12 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
13 legislation is requested. The nature of the emergency is that these
14 funds must be appropriated prior to the end of fiscal year 2020-2021.

15 **Section 5. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor’s signature.
