The funding above in the amount of \$4,028,009.00 consists of \$2,948,009.00 in annual Federal HOME Investment Partnership (HOME) Grant Program funding from the U.S. Housing and Urban Development, Department of \$1,080,000.00 in program income. Jurisdictions must match every dollar of HOME funds used (except for administrative costs) with 25 cents from nonfederal sources, which may include donated materials or labor, the value of donated property, proceeds from bond financing, and other resources. The City meets this match by utilizing State Housing requirement Initiative Partnership (SHIP) funds for activities and recipients that are eligible under the HOME program.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for a wide range of activities, including building, buying, and/or rehabilitating affordable housing for rent or homeownership for, or providing direct rental assistance to, low income individuals and families. The Schedule of Proposed Funding detailing the proposed use of funds is attached hereto as Exhibit 2 and incorporated herein by this reference.
