4 **ORDINANCE 2020-205-E**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 MAYOR, OR HIS DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE A SECOND AMENDMENT TO THE  
8 EXISTING AGREEMENT WITH ADVANCED DISPOSAL  
9 SERVICES JACKSONVILLE, LLC; SETTING RATES FROM  
10 THE 2019 RATE REVIEW COMMENCING OCTOBER 1,  
11 2019; SETTING FUEL CAPS FOR FISCAL YEARS 2019-  
12 2020, 2020-2021, AND 2021-2022; AUTHORIZING  
13 DUAL USE OF THE JACKSONVILLE AREA RESIDENTIAL  
14 (JAR) FACILITY; APPROVING THE PREMISE COUNT  
15 CONDUCTED IN CONNECTION WITH THE RATE REVIEW;  
16 PROVIDING FOR A MARKUP ON EXPENSES; PROVIDING  
17 FOR CITY OVERSIGHT BY THE SOLID WASTE DIVISION  
18 OF THE DEPARTMENT OF PUBLIC WORKS; PROVIDING  
19 AN EFFECTIVE DATE.

21 **WHEREAS**, Chapter 382, Part 3, *Ordinance Code*, provides for a  
22 rate review to determine the rate and measure of compensation to be  
23 paid each residential waste and recycling contractor's Agreement  
24 for Residential Waste and Recycling Collection and Transportation  
25 Services (the "Residential Collection Agreements") with the City,  
26 and the Residential Collection Agreements also provide for rate  
27 review and rate adjustment; and

28 **WHEREAS**, the Council approved an amended and restated contract  
29 with Advanced Disposal Services Jacksonville, LLC ("ADS") pursuant  
30 to Ordinance 2015-477-E (the "Contract") and a First Amendment to

1 the Contract pursuant to Ordinance 2017-57-E; and

2 **WHEREAS**, the Council Auditor and Administration performed a  
3 rate review of the compensation previously paid and projected to be  
4 paid to ADS for residential waste (garbage, yard waste, tires, and  
5 white goods) and recycling collection and transportation services  
6 to the City, and reported their review and rate recommendation to  
7 the Council; and

8 **WHEREAS**, the Council has established a rate to be paid to ADS;  
9 now therefore

10 **BE IT ORDAINED** by the Council of the City of Jacksonville:

11 **Section 1. Approval and authorization to execute.** The  
12 terms established by the Council Rate Review process as set forth  
13 in **Exhibit 2**, attached hereto and incorporated herein by this  
14 reference, are hereby approved, and the Mayor, or his designee, and  
15 the Corporation Secretary are hereby authorized to execute the  
16 Second Amendment to the Amended and Restated Agreement for  
17 Residential Waste and Recycling Collection and Transportation  
18 Services between the City and ADS, in substantially the same form  
19 attached hereto as **Exhibit 1** and incorporated herein by this  
20 reference, which incorporates the terms set forth in **Exhibit 2**.

21 **Section 2. Mark-up on Expenses.** The monthly base rate  
22 component of \$10.34 set forth in **Exhibit 2** represents a mark-up of  
23 17.50% from agreed upon operating expenses of \$7,803,754.00 before  
24 profit, interest expenses, and corporate taxes.

25 **Section 3. Dual Use of JAR Facility.** ADS's dual use of  
26 the Jacksonville Area Residential (JAR) Facility is hereby  
27 authorized subject to the terms and conditions outlined in **Exhibit**  
28 **1**.

29 **Section 4. Oversight.** The Solid Waste Division of the  
30 Department of Public Works shall oversee the Residential Collection  
31 Agreement described herein.

1           **Section 5.           Effective Date.**   This ordinance shall become  
2 effective upon signature by the Mayor or upon becoming effective  
3 without the Mayor's signature.
