5 AN ORDINANCE APPROPRIATING \$200,000 FROM A
6 SPECIAL COUNCIL CONTINGENCY TO THE SAN MATEO
7 LITTLE LEAGUE COMPLEX - OTHER CONSTRUCTION COSTS
8 ACCOUNT TO PROVIDE FUNDS FOR CONSTRUCTION OF A
9 STORAGE FACILITY AT THE SAN MATEO LITTLE LEAGUE
10 PARK; AMENDING THE 2025-2029 FIVE-YEAR CAPITAL
11 IMPROVEMENT PLAN APPROVED BY ORDINANCE
12 2024-505-E TO EXPAND THE SCOPE OF THE "SAN MATEO
13 LITTLE LEAGUE COMPLEX" PROJECT (THE "PROJECT")
14 TO INCLUDE CONSTRUCTION OF A STORAGE FACILITY
15 AND TO REFLECT THIS APPROPRIATION OF FUNDS TO
16 THE PROJECT FOR THIS PURPOSE; PROVIDING AN
17 EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
21 within the City's budget, there is hereby appropriated the indicated
22 sum(s) from the account(s) listed in subsection (a) to the account(s)
23 listed in subsection (b):

31 The funding above represents an appropriation of \$200,000

1 from a Special Council Contingency to the San Mateo Little
2 League Complex - Other Construction Costs account to
3 provide funds for construction of a storage facility at
4 San Mateo Little League Park.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide funds for construction of a storage facility
7 for the San Mateo Little League Complex at San Mateo Little League
8 Park.

9 **Section 3. Capital Improvement Plan Amendment.** Ordinance
10 2024-505-E, adopting the 2025-2029 Five-Year Capital Improvement Plan
11 (the "CIP") for the City and certain of its independent agencies, is
12 hereby amended to expand the scope of the "San Mateo Little League
13 Complex" project (the "Project") to include construction of a storage
14 facility and to reflect this appropriation of funds to the Project
15 for this purpose as reflected in the Project Information Sheet
16 attached hereto as **Exhibit 2** and incorporated herein by this
17 reference. The City Council finds that the deferral of this amendment
18 of the CIP until the next annual budget and CIP review will be
19 detrimental to the best interests of the community because such
20 deferral will unnecessarily delay commencement and completion of
21 construction of a storage facility at San Mateo Little League Park.

22 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of
23 this Ordinance requires the affirmative vote of two-thirds of the
24 City Council members present at the meeting because of the CIP
25 amendment set forth in this Section. This Ordinance shall constitute
26 an amendment to Ordinance 2024-505-E. In all other respects, the
27 Five-Year Capital Improvement Plan approved by Ordinance 2024-505-E
28 shall remain unchanged and continue in full force and effect.

29 **Section 4. Effective Date.** This Ordinance shall become
30 effective upon signature by the Mayor or upon becoming effective
31 without the Mayor's signature.
