AN ORDINANCE APPROPRIATING \$50,000.00 IN STATE FUNDING FROM THE GRANT STATE OF FLORIDA, DEPARTMENT OF STATE, DIVISION OF HISTORICAL SURVEY RESOURCES TO FUND Α OF HISTORIC STRUCTURES WITHIN THE BOUNDARIES OF THE LOCALLY DESIGNATED SPRINGFIELD HISTORIC DISTRICT, AS INITIATED BY B.T. 24-026; PURPOSE APPROPRIATION; APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A GRANT AGREEMENT WITH THE STATE OF FLORIDA, DEPARTMENT OF STATE, FOR THE PURPOSE OF PROVIDING THE GRANT FUNDS TO THE CITY; PROVIDING FOR OVERSIGHT BY THEPLANNING AND DEVELOPMENT DEPARTMENT; REQUESTING ONE-CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

The funding above represents an appropriation of state grants funds held in the Miscellaneous Grant Projects fund

to conduct a survey of historic structures in the

Springfield Historic District.

Explanation of Appropriation:

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide grant funding of \$50,000 to conduct a survey of historic structures in the Springfield Historic District. The scope of work includes procuring professional historic preservation services, conducting archival research, and conducting field surveys.

Agreement. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver, the Grant Agreement between the City of Jacksonville and the State of Florida, Department of State, in substantially the same form as attached as Exhibit 2 and incorporated herein by reference for the purposes of providing funds for the grant to the City and enabling the City to fund a survey of historic buildings in the Springfield Historic District.

Section 4. Oversight. The City of Jacksonville Planning and Development Department will provide oversight.

Section 5. Requesting One-cycle Emergency Passage Pursuant to Council Rule 4.901 (Declaration of Emergency), Part 9 (Emergency Legislation), Chapter 4 (Procedures). One-cycle emergency passage of this legislation is requested. The nature of the emergency is that pursuant to the terms of the grant, which was not received until September 12, 2023, the City must complete the historic survey by June 30, 2024. Time is of the essence to appropriate the grant funds

Section 6. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
