11 ELECTIONS, TO PAY FOR ELECTION EDUCATION AND THE
12 MAILING OF SAMPLE BALLOTS, AS INITIATED BY B.T.
13 24-102; PROVIDING FOR CARRYOVER OF FUNDS INTO
14 FISCAL YEAR 2024-2025; PROVIDING AN EFFECTIVE
15 DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
19 within the City's budget, there are hereby appropriated the indicated
20 sum(s) from the account(s) listed in subsection (a) to the account(s)
21 listed in subsection (b):

28 (c) **Explanation of Appropriation** - The funding above represents
29 investment pool earnings generated from the Help America
30 Vote Act (HAVA) grant from the U.S. Election Assistance
31 Commission through the State of Florida, Department of

1 State, Division of Elections, and will be used for election
2 education and the mailing of sample ballots.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to provide funding to the City for election education
5 and the mailing of sample ballots. The State of Florida, Department
6 of State, Division of Elections, has requested that all remaining
7 funds related to the HAVA grant program be used to close out the
8 program.

9 **Section 3. Carryover.** The funds appropriated in this
10 Ordinance shall not lapse but shall carryover to fiscal year 2024-
11 2025.

12 **Section 4. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
