AN ORDINANCE PROVIDING FORGIVENESS TO THE JACKSONVILLE FRATERNAL ORDER OF POLICE FOUNDATION, INC. ("FOP FOUNDATION"), FOR NON-COMPLIANCE WITH THE AUDIT REPORTING REQUIREMENTS OF SECTIONS 118.201 (RELEASE OF APPROPRIATIONS) AND 118.202 (CONTENT OF AUDITS BY INDEPENDENT CERTIFIED PUBLIC ACCOUNTANT), PART 2 (DISBURSEMENT OF CITY GRANTS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*; AUTHORIZING THE COUNCIL AUDITOR TO REMOVE THE FOP FOUNDATION FROM THE CHAPTER 118 NON-COMPLIANCE LIST; REQUIRING THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT TO COORDINATE WITH THE COUNCIL AUDITOR'S OFFICE TO EFFECTUATE THIS ORDINANCE; PROVIDING FOR AN EFFECTIVE DATE.

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals, and welfare):

This Ordinance provides forgiveness to The Jacksonville Fraternal Order of Police Foundation, Inc. for non-compliance with the audit reporting requirements of Sections 118.201 and 118.202 of the City's Ordinance Code. This non-compliance resulted in the FOP Foundation being placed on the Council Auditor's non-compliance list. This bill authorizes the entity's removal from the non-compliance list so FOP Foundation may pursue additional grant funding from the City. This legislation serves the public welfare by allowing an entity that provides various charitable and educational services to the community, including providing immediate financial relief to police and correctional officers who are sick, injured, or killed and/or their immediate family that is impacted by the illness, injury or loss to continue providing these charitable services.
