4 **ORDINANCE 2022-368-E**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE
6 PARKS, RECREATION AND COMMUNITY SERVICES
7 DEPARTMENT DIRECTOR TO ACCEPT, A DONATION FROM
8 LIFT JAX, INC. OF NEW PLAYGROUND EQUIPMENT FOR
9 FLOSSIE BRUNSON EASTSIDE PARK VALUED AT
10 \$425,437.96, IN ACCORDANCE WITH SECTION
11 111.105 (b), *ORDINANCE CODE*, WHICH DONATION
12 INCLUDES THE COSTS FOR REMOVAL OF EXISTING
13 PLAYGROUND EQUIPMENT, DESIGN COSTS, SITE WORK,
14 AND INSTALLATION OF THE NEW PLAYGROUND
15 EQUIPMENT; PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, LIFT JAX, Inc. has generously offered to donate new
18 playground equipment for Flossie Brunson Eastside Park, located at
19 1050 Franklin Street in Council District 7 (the "Park"); and

20 **WHEREAS**, this Park was selected due to the dated composition of
21 the existing playground and the extensive use of this playground by
22 surrounding residents and families; and

23 **WHEREAS**, this donation includes installation of seven pieces of
24 playground equipment, freight, removal and disposal of existing
25 playground equipment, and the costs for materials and installation
26 of concrete curbing, safety surfacing, and compacted stone sub-base,
27 as well as dumpster fees and disposal of refuse, permit fees and
28 engineered stamped drawings which together are valued at \$425,437.96;
29 and

30 **WHEREAS**, the Parks, Recreation and Community Services Department
31 desires to accept this donation of labor and materials (playground

1 equipment) for use in the Park and is seeking City Council approval
2 of the donation in accordance with Section 111.105(b), *Ordinance*
3 *Code*; now, therefore

4 **BE IT ORDAINED** by the Council of the City of Jacksonville:

5 **Section 1.** The City Council hereby approves, and authorizes
6 the Parks, Recreation and Community Services Department Director to
7 accept, the generous donation of new playground equipment, including
8 removal of existing equipment, site work, and installation of the new
9 equipment, for Flossie Brunson Eastside Park from LIFT JAX, Inc.
10 valued at \$425,437.96, in accordance with Section 111.105(b),
11 *Ordinance Code*.

12 **Section 2. Effective Date.** This Ordinance shall
13 become effective upon signature by the Mayor or upon becoming
14 effective without the Mayor's signature.
