5 **ORDINANCE 2022-492**

6 AN ORDINANCE MAKING CERTAIN FINDINGS; APPROVING
7 THE APPLICATION OF AETNA RECYCLING, INC. FOR
8 RENEWAL OF ITS CERTIFICATE OF PUBLIC CONVENIENCE
9 AND NECESSITY (CON) TO OPERATE A YARD TRASH
10 RECYCLING FACILITY WITH A MODIFICATION TO ALLOW
11 FOR THE ADDITION OF CLEAN DEBRIS RECYCLING;
12 PROVIDING FOR CONDITIONS OF SAID RENEWAL;
13 PROVIDING AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to Chapter 380, *Ordinance Code*, Aetna
16 Recycling, LLC (the "Applicant") has applied for renewal of its
17 Certificate of Public Convenience and Necessity (CON) for the
18 continued operation of a yard trash recycling facility with a
19 modification to allow for the addition of clean debris recycling at
20 Applicant's facility located at 8050 Old Kings Road, Jacksonville,
21 Florida 32217 (the "Facility"); and

22 **WHEREAS**, the initial CON authorizing operation of a yard trash
23 recycling facility was granted by Ordinance 2013-458-E; and

24 **WHEREAS**, based upon the determination of need for the Facility
25 by the City Council, the Solid Waste Division of the Department of
26 Public Works supports approval of the application for renewal and
27 modification of the Certificate of Public Convenience and Necessity
28 for Aetna Recycling, Inc., provided the Applicant agrees to accept
29 and comply with the Specific Operating Conditions contained in **Exhibit**
30 **1**, attached hereto and incorporated herein by this reference; and

31 **WHEREAS**, the City Council has caused a public hearing, properly

1 noticed, to be held before the Council Committee to which matters
2 regarding public utilities are referred, as required by Chapter 380,
3 *Ordinance Code*, and has made certain findings with respect to said
4 application; now therefore

5 **BE IT ORDAINED** by the Council of the City of Jacksonville:

6 **Section 1. Making Findings.** Based upon the criteria set
7 forth in Section 380.105, *Ordinance Code*, and the comments and
8 recommendations of the Director of the Planning and Development
9 Department, the Chief of the Solid Waste Division, the Chief of the
10 Environmental Quality Division, and the Florida Department of Health
11 in Duval County, the Council finds that the Facility would serve the
12 public convenience and provide a needed service to the citizens of
13 Duval County.

14 **Section 2. Renewal and Modification of Certificate of**
15 **Public Convenience and Necessity (CON) Granted.** In accordance
16 with Chapter 380, *Ordinance Code*, the City of Jacksonville hereby
17 grants renewal and modification of the Certificate of Public
18 Convenience and Necessity (CON) to Aetna Recycling, Inc. for the
19 continued operation of a yard trash recycling facility with the
20 addition of clean debris recycling as described in **Exhibit 1**, and as
21 described in the submitted and approved application.

22 **Section 3. Conditions.** The Certificate of Public
23 Convenience and Necessity shall be subject to the conditions set
24 forth in the "Aetna Recycling, Inc. Clean Debris & Yard Trash
25 Recycling Facility Certificate of Public Convenience and Necessity
26 Specific Operating Conditions" attached hereto as **Exhibit 1**. The
27 comments and recommendations of the appropriate representatives from
28 the Public Works Department, the Planning and Development Department,
29 the Neighborhoods Department Environmental Quality Division, and the
30 Florida Department of Health are attached hereto as **Exhibit 2** and

1 incorporated herein by this reference. A copy of the CON Monthly
2 Waste Analysis Report form is attached hereto as **Exhibit 3.**

3 **Section 4. Effective Date.** This Ordinance shall
4 become effective upon signature by the Mayor or upon becoming
5 effective without the Mayor's signature.
