6 A RESOLUTION CONFIRMING THE APPOINTMENT OF BRIAN  
7 CHAPPELL, A DUVAL COUNTY RESIDENT, AS A MEMBER  
8 OF THE JACKSONVILLE POLICE AND FIRE PENSION FUND  
9 FINANCIAL INVESTMENT AND ADVISORY COMMITTEE,  
10 REPLACING JAMES MATTERA, PURSUANT TO SECTION  
11 121.503 (FINANCIAL INVESTMENT AND ADVISORY  
12 COMMITTEE; MEMBERSHIP, APPOINTMENT AND TERMS),  
13 *ORDINANCE CODE*, FOR A FIRST FULL TERM ENDING  
14 MARCH 1, 2024; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, Ordinance 2015-304-E enacted June 9, 2015, established  
17 the Financial Investment and Advisory Committee ("Committee") to  
18 provide advice to the Jacksonville Police and Fire Pension Board of  
19 Trustees ("Board") on: (1) financial matters; (2) actuarial practices  
20 and assumptions; (3) investment strategy and policy; (4) the selection  
21 of outside financial services providers, including investment  
22 managers and advisors; and (5) such other matters as requested by the  
23 Board; and

24 **WHEREAS**, Committee members shall be financially sophisticated  
25 professionals with expertise in any or all of the following  
26 competencies: actuarial science, fiscal operations, or investment  
27 practices; which will include knowledge, of and experience and  
28 familiarity with, portfolio and/or pension fund management,  
29 institutional investment and fiduciary responsibilities; and

30 **WHEREAS**, members of the Financial Investment and Advisory  
31 Committee must be residents of Duval, Nassau, St. Johns, Baker or

1 Clay County, Florida; and

2       **WHEREAS**, the five members of the Committee are nominated by the  
3 Board and are subject to confirmation by the Council; and

4       **WHEREAS**, at its June 17, 2022 meeting, the Board nominated Brian  
5 Chappell to be appointed as a member of the Committee, as evidenced  
6 by Police and Fire Pension Fund Resolution 2022-06-17-VIII-a, a copy  
7 of which is attached hereto as **Exhibit 1**; now therefore

8       **BE IT RESOLVED** by the Council of the City of Jacksonville:

9       **Section 1. Confirmation.** The Council hereby confirms the  
10 Police and Fire Pension Fund appointment of Brian Chappell, a Duval  
11 County resident, to the Financial Investment and Advisory Committee,  
12 replacing James Mattera, in accordance with Section 121.503  
13 (Financial Investment and Advisory Committee; Membership, Appointment  
14 and Terms), *Ordinance Code*, for a first full term expiring on March  
15 1, 2024.

16       **Section 2. Effective Date.** This resolution shall become  
17 effective upon signature by the Mayor or upon becoming effective  
18 without the Mayor's signature.
