5 AN ORDINANCE APPROPRIATING \$153,000.00 FROM THE
6 SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND")
7 FOR DONATIONS TO BIG BROTHERS BIG SISTERS OF
8 NORTHEAST FLORIDA, INC. (\$15,000.00), DOWNTOWN
9 VISION ALLIANCE, INC. (\$10,000.00), FLORIDA
10 SHERIFFS YOUTH RANCHES, INC. (\$20,000.00),
11 OPERATION SAVE OUR SONS, INC. (\$40,000.00), AND
12 THE ORANGE COUNTY SHERIFF'S OFFICE, NATIONAL
13 CONFERENCE ON PREVENTING CRIME IN THE BLACK
14 COMMUNITY (\$3,000.00) IN ACCORDANCE WITH SECTION
15 932.7055(5), FLORIDA STATUTES, TO SUPPORT SCHOOL
16 RESOURCE OFFICER, CRIME PREVENTION, SAFE
17 NEIGHBORHOOD, AND DRUG ABUSE EDUCATION AND
18 PREVENTION PROGRAMS, APPROPRIATING \$65,000.00
19 FROM THE FUND TO REIMBURSE THE GENERAL FUND FOR
20 FORFEITURE-RELATED EXPENDITURES IN ACCORDANCE
21 WITH SECTION 932.7055(4)(C), FLORIDA STATUTES,
22 AND REALLOCATING A TOTAL OF \$82,610.40 IN PRIOR
23 YEAR RESIDUAL BALANCES, AS INITIATED BY B.T. 21-
24 063; PURPOSE OF APPROPRIATION; APPROVING AND
25 AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE
26 CORPORATION SECRETARY TO EXECUTE AND DELIVER ON
27 BEHALF OF THE CITY, THE MISCELLANEOUS
28 APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF
29 JACKSONVILLE AND BIG BROTHERS BIG SISTERS OF
30 NORTHEAST FLORIDA, INC., THE MISCELLANEOUS
31 APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF

1 JACKSONVILLE AND DOWNTOWN VISION ALLIANCE, INC.,
2 THE MISCELLANEOUS APPROPRIATIONS AGREEMENT
3 BETWEEN THE CITY OF JACKSONVILLE AND FLORIDA
4 SHERIFFS YOUTH RANCHES, INC., AND THE
5 MISCELLANEOUS APPROPRIATIONS AGREEMENT BETWEEN
6 THE CITY OF JACKSONVILLE AND OPERATION SAVE OUR
7 SONS, INC.; PROVIDING FOR CITY OVERSIGHT BY THE
8 JACKSONVILLE SHERIFF'S OFFICE; PROVIDING AN
9 EFFECTIVE DATE.

11 **BE IT ORDAINED** by the Council of the City of Jacksonville:

12 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
13 within the City's budget, there is hereby appropriated the indicated
14 sum(s) from the account(s) listed in subsection (a) to the account(s)
15 listed in subsection (b):

16 (B.T. 21-063 attached hereto as **Exhibit 1** and incorporated herein by
17 this reference)

22 (c) Explanation of Appropriation:

23 The funding above represents an appropriation of \$88,000.00
24 from the Special Law Enforcement Trust Fund for donations
25 to various organizations as set forth herein to support
26 school resource officer, crime prevention, safe
27 neighborhood, and drug abuse education and prevention
28 programs administered by various agencies. In addition,
29 the funding above represents an appropriation of \$65,000.00
30 from the Fund to reimburse the General Fund for forfeiture-
31 related expenditures, and a reallocation of \$82,610.40 in

1 prior year residual balances.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to provide donations to the following organizations, in
4 the stated amounts: Big Brothers Big Sisters of Northeast Florida,
5 Inc. (\$15,000.00), Downtown Vision Alliance, Inc. (\$10,000.00),
6 Florida Sheriffs Youth Ranches, Inc. (\$20,000.00), Operation Save Our
7 Sons, Inc. (\$40,000.00), and Orange County Sheriff's Office, National
8 Conference on Preventing Crime in the Black Community (\$3,000.00).
9 This allocation supports school resource officer, crime prevention,
10 safe neighborhood, and drug abuse education and prevention program
11 services to the citizens of the City of Jacksonville, Duval County,
12 Florida. A Certification from the Jacksonville Sheriff's Office that
13 the subject appropriation from the Special Law Enforcement Trust Fund
14 complies with Section 932.7055, Florida Statutes, is attached hereto
15 as **Exhibit 2** and incorporated herein by this reference.

16 In addition to the above, this appropriation includes a transfer
17 of \$65,000.00 from the Fund to the General Fund as a reimbursement
18 for forfeiture-related expenditures in accordance with Section
19 932.7055(4)(c), Florida Statutes, and a reallocation of \$82,610.40
20 in residual balances from prior year appropriations.

21 **Section 3. Approval and Authorization.** There is hereby
22 approved, and the Mayor, or his designee, and the Corporation
23 Secretary are hereby authorized to execute and deliver on behalf of
24 the City, the Miscellaneous Appropriations Agreement between the City
25 of Jacksonville and Big Brothers Big Sisters of Northeast Florida,
26 Inc., the Miscellaneous Appropriations Agreement between the City of
27 Jacksonville and Downtown Vision Alliance, Inc., the Miscellaneous
28 Appropriations Agreement between the City of Jacksonville and the
29 Florida Sheriffs Youth Ranches, Inc., and the Miscellaneous
30 Appropriations Agreement between the City of Jacksonville and
31 Operation Save Our Sons, Inc., in substantially the same forms as

1 have been placed **On File** with the Office of Legislative Services.

2 **Section 4. Oversight.** The Jacksonville Sheriff's Office
3 shall oversee the projects described herein.

4 **Section 5. Effective Date.** This Ordinance shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
