4 **ORDINANCE 2024-729**

5 AN ORDINANCE CREATING A NEW SECTION 122.609
6 (AMENDMENT FOR USING AGENCY FOR OWNER DIRECT
7 PURCHASE (ODP) OF MATERIALS), PART 6 (CAPITAL
8 IMPROVEMENT PLAN), CHAPTER 122 (PUBLIC
9 PROPERTY), *ORDINANCE CODE*, TO FACILITATE THE
10 OWNER DIRECT PURCHASE OF SUPPLIES BY ALLOWING
11 THE TRANSFER OF FUNDS WITHIN A SINGLE PROJECT
12 WITHOUT MODIFYING THE OVERALL BUDGET OF THE
13 PROJECT; PROVIDING CODIFICATION INSTRUCTIONS;
14 PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, Ordinance 2023-20-E, as codified in Section 126.306(h)
17 of the Procurement Code, mandates the owner direct purchase of
18 supplies identified on the schedules of values having a cost of
19 \$10,000 or more for Jacksonville Small and Emerging Business (JSEB)
20 contracts and \$100,000 or more for non-JSEB contracts; and

21 **WHEREAS**, to fulfill this mandate, it is necessary to have the
22 ability to transfer funds between expense accounts within a single
23 project and without modifying the overall budget thereof; now
24 therefore

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Creating a new Section 122.609 (Amendment by**
27 **Using Agency for Owner Direct Purchase (ODP) of Materials), Part 6**
28 **(Capital Improvement Plan), Chapter 122 (Public Property), Ordinance**
29 **Code.** Section 122.609 (Amendment by Using Agency for Owner Direct
30 Purchase (ODP) of Materials), Part 6 (Capital Improvement Plan),
31 Chapter 122 (Public Property), *Ordinance Code*, is hereby created to

2 **Chapter 122. PUBLIC PROPERTY**

4 **Part 6. CAPITAL IMPROVEMENT PLAN**

6 **Sec. 122.609. - Amendment by Using Agency for Owner Direct Purchase**
7 **(ODP) of Materials.** For the owner direct purchase of materials, and
8 pursuant to Section 126.306 (h), a using agency may amend the Capital
9 Improvement Plan through the transfer of funds to and/or from material
10 purchase accounts and other accounts within a single project. Request
11 for such accounting transfers shall not affect the overall budget of
12 a single project and shall be made in writing to the Finance
13 Department. Any amendment made pursuant to this section shall become
14 effective upon review and approval by the Finance Department.

16 **Section 2. Codification Instructions.** The Codifier and the
17 Office of General Counsel are authorized to make all chapter and
18 division "tables of contents" consistent with the changes set forth
19 herein. Such editorial changes and any others necessary to make the
20 *Ordinance Code* consistent with the intent of the legislation are
21 approved and directed herein, and changes to the *Ordinance Code* shall
22 be made forthwith and when inconsistencies are discovered.

23 **Section 3. Effective Date.** This ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
