7 CAPITAL SUBFUND FLEX FIELD/AMPHITHEATER
8 PROJECT TO BALANCE REVENUE AND EXPENSE BUDGET
9 TO REVENUE AND EXPENSE ACTUALS AND TO CORRECT
10 NEGATIVE BALANCES IN THE FINANCIAL SYSTEM
11 REQUIRED FOR 1CLOUD IMPLEMENTATION, AS
12 INITIATED BY B.T. 20-043; AMENDING THE 2020-
13 2024 FIVE-YEAR CAPITAL IMPROVEMENT PROGRAM
14 APPROVED BY ORDINANCE 2019-505-E TO TRANSFER
15 FUNDING IN THE PROJECT ENTITLED "EVERBANK
16 FIELD IMPROVEMENTS AMEND 14;" PROVIDING AN
17 EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
21 within the City's budget, there are hereby appropriated the
22 indicated sum(s) from the account(s) listed in subsection (a) to
23 the account(s) listed in subsection (b):

30 (c) Explanation of Appropriation
31 The funding above is a transfer of available funding in

1 the sports complex capital subfund flex
2 field/amphitheater project to balance revenue and expense
3 budget to revenue and expense actuals and thus correct
4 negative balances in the financial system required for
5 1Cloud implementation.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to transfer available revenue in the sports complex
8 capital subfund flex field/amphitheater project to balance revenue
9 and expense budget to revenue and expense actuals and thus correct
10 negative balances in the financial system required for 1Cloud
11 implementation.

12 **Section 3. CIP Amendment.** Ordinance 2019-505-E, being
13 the 2020-2024 Five-Year Capital Improvement Program for the City
14 and certain of its independent agencies, is hereby amended to
15 transfer available funding in the project entitled "Everbank Field
16 Improvements Amend 14." The project is more fully described in the
17 Project Information Sheet, attached hereto as **Exhibit 2** and
18 incorporated herein by this reference. The Council finds that the
19 deferral of this amendment of the CIP until the next annual budget
20 and CIP review will be detrimental to the best interests of the
21 community because such deferral will result in unnecessary delay in
22 implementation of 1Cloud. Pursuant to Section 122.605(c), *Ordinance*
23 *Code*, enactment of this ordinance requires the affirmative vote of
24 two-thirds of the Council members present at the meeting because of
25 the CIP amendment set forth in this section. This ordinance shall
26 constitute an amendment to Ordinance 2019-505-E. In all other
27 respects, the Five-Year Capital Improvement Program approved by
28 Ordinance 2019-505-E shall continue in full force and effect.

29 **Section 4. Effective Date.** This ordinance shall become
30 effective upon signature by the Mayor or upon becoming effective
31 without the Mayor's signature.
