5 AN ORDINANCE ALLOCATING \$78,443.00 IN GRANT  
6 FUNDS FROM THE U.S. DEPARTMENT OF HEALTH AND  
7 HUMAN SERVICES HIV EMERGENCY RELIEF PROJECT  
8 GRANT, ORIGINALLY APPROPRIATED PURSUANT TO  
9 ORDINANCE 2023-504-E FOR THE RYAN WHITE HIV/AIDS  
10 PART A PROGRAM (THE "PROGRAM"), TO FUND A NEW  
11 FULL-TIME ACCOUNTANT SENIOR POSITION WITHIN THE  
12 SOCIAL SERVICES DIVISION OF THE PARKS,  
13 RECREATION AND COMMUNITY SERVICES DEPARTMENT,  
14 WITH NO LOCAL MATCH REQUIRED, TO SUPPORT THE  
15 PROGRAM, AS INITIATED BY B.T. 24-060; PURPOSE OF  
16 APPROPRIATION; AUTHORIZING SAID ACCOUNTANT  
17 SENIOR POSITION, AS INITIATED BY R.C. 24-064;  
18 PROVIDING FOR AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
22 within the City's budget, there is hereby appropriated the indicated  
23 sum from the account(s) listed in subsection (a) to the account(s)  
24 listed in subsection (b):

- 31 (c) Explanation of Appropriation:

1 The funding above represents an allocation of grant funds  
2 from the U.S. Department of Health and Human Services HIV  
3 Emergency Relief Project Grant, originally appropriated  
4 pursuant to Ordinance 2023-504-E for the Program, to fund  
5 a new Accountant Senior position with the Social Services  
6 Division of the Parks, Recreation and Community Services  
7 Department. This position is fully grant funded and there  
8 are no City matching funds required.

9 **Section 2. Purpose.** The purpose of the appropriation in  
10 Section 1 is to fund a full-time Accountant Senior position within  
11 the Social Services Division so that this full-time position replaces  
12 the part-time hours budgeted for the position. The Accountant Senior  
13 will be responsible for accounting services related to the City's  
14 HIV-related health and support services provided through the Program  
15 to individuals living with HIV/AIDS residing in the Jacksonville  
16 Transitional Grant Area (comprised of Duval, Clay, Nassau, and St.  
17 Johns counties).

18 **Section 3. Approval of Position.** There is hereby approved  
19 the Accountant Senior position more fully described in R.C. 24-064,  
20 attached hereto as **Exhibit 2** and incorporated herein by this  
21 reference.

22 **Section 4. Oversight Department.** The Social Services  
23 Division of the Parks, Recreation and Community Services Department  
24 shall oversee the Program and position described herein.

25 **Section 5. Effective Date.** This Ordinance shall become  
26 effective upon signature by the Mayor or upon becoming effective  
27 without the Mayor's signature.
