6 AN ORDINANCE APPROPRIATING \$543,289.35 IN
7 GRANT FUNDS FROM THE U. S. DEPARTMENT OF
8 JUSTICE, BUREAU OF JUSTICE ASSISTANCE, THROUGH
9 THE STATE ATTORNEY'S OFFICE, FOURTH JUDICIAL
10 CIRCUIT OF FLORIDA, UNDER THE FISCAL YEAR 2018
11 NATIONAL SEXUAL ASSAULT KIT INITIATIVE (SAKI),
12 WITH NO LOCAL MATCH, TO PROVIDE SALARIES AND
13 BENEFITS TO ONE FULL-TIME COLD CASE DETECTIVE
14 IN FISCAL YEAR 2020 AND FISCAL YEAR 2021 WHO
15 WILL WORK EXCLUSIVELY ON SAKI, INCLUDING
16 TRAVELING TO COLLECT LAWFULLY OWNED DNA
17 EVIDENCE, AND TO PROVIDE FUNDS FOR THE
18 PURCHASE OF ADDITIONAL SUPPLIES TO FACILITATE
19 THE COLLECTION AND TESTING OF DNA EVIDENCE, AS
20 INITIATED BY B.T. 20-007; APPROVING AND
21 AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND
22 THE CORPORATION SECRETARY TO EXECUTE AND
23 DELIVER, FOR AND ON BEHALF OF THE CITY, THE
24 SUBCONTRACT BETWEEN THE STATE ATTORNEY'S
25 OFFICE, 4TH JUDICIAL CIRCUIT, AND THE
26 JACKSONVILLE SHERIFF'S OFFICE (JSO); PROVIDING
27 FOR OVERSIGHT BY THE JSO DEPARTMENT OF
28 INVESTIGATIONS AND HOMELAND SECURITY;
29 APPROVING POSITION, AS INITIATED BY R.C. 20-
30 005; PROVIDING FOR AN EFFECTIVE DATE.

1 **BE IT ORDAINED** by the Council of the City of Jacksonville:

2 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
3 within the City's budget, there is hereby appropriated the
4 indicated sum from the account listed in subsection (a) to the
5 account listed in subsection (b):

12 (c) Explanation of Appropriation.

13 The funding above is a grant from the U. S. Department of
14 Justice, Bureau of Justice Assistance, through the State
15 Attorney's Office, Fourth Judicial Circuit of Florida,
16 under the Fiscal Year 2018 National Sexual Assault Kit
17 Initiative (SAKI). No local match is required. The grant
18 period is from October 1, 2018, through September 30,
19 2021. A copy of the sub-award letter from the State
20 Attorney's Office is attached hereto as **Exhibit 2** and
21 incorporated herein by this reference.

22 **Section 2. Purpose.** The purpose of the appropriation in
23 Section 1 is to provide salaries and benefits to one full-time cold
24 case detective in Fiscal Year 2020 and Fiscal Year 2021 who will
25 work exclusively on SAKI, including traveling to collect lawfully
26 owned DNA evidence, and to provide funds for the purchase of
27 additional supplies to facilitate the collection and testing of DNA
28 evidence.

29 **Section 3. Approval and authorization.** There is hereby
30 approved, and the Mayor, or his designee, and Corporation Secretary
31 are hereby authorized to execute and deliver, the Subcontract

1 between the State Attorney's Office, 4th Judicial Circuit, and the
2 Jacksonville Sheriff's Office (JSO), a copy of which has been
3 placed **ON FILE** with the Office of Legislative Services.

4 **Section 4. Oversight.** The JSO Department of
5 Investigations and Homeland Security shall oversee the project
6 described herein.

7 **Section 5. Approval of Position.** There is hereby
8 approved the position more fully described in R.C. 20-005, attached
9 hereto as **Exhibit 3** and incorporated herein by this reference.

10 **Section 6. Effective Date.** This ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
