This is Ability Housing's formal request for a budget amendment regarding the City of Jacksonville's FY 2023-2024 Permanent Supportive Housing Pilot Program.

We propose a budget amendment to reallocate \$50,000, which represents ten percent of the total grant award, from the "Client Other: PSH Rent Assistance & Supportive Services" category to the following administrative expenses for the operation of the grant:

Program Director	\$12,000
Housing Program Manager	\$15,000
Development Manager	\$10,000
Professional Fees - Finance and Accounting	\$13,000
Total	\$50,000

The reallocation aligns with industry best practices, recognizing that grant recipients incur administrative and overhead costs necessary for program operation and grant management. Previously, the contract provided a flat rate per client that encompassed all permanent supportive housing expenses, including client costs, supportive services, and administrative fees.

The amendment reduces the "Client Other: PSH Rent Assistance and Utilities" line item to \$425,000 and separates the administrative costs into four distinct line items. This adjustment ensures compliance with the City of Jacksonville's new auditing requirements, which mandate detailed reporting of all grant expenses. Pending approval from the City Council, we will use the figures in the attached budget amendment request form for our December 2024 invoice onwards.
