- The chairman, Clay Whitfield, called the meeting to order (Recording 01:00))

**Clay introduces next order of business: (Recording: (13:20)**

**Riverside Presbyterian Day School (RPDS) Addressing concerns (13:40)**

**Rollins Presents:**

- RPDS would Like to present the current address to the committee to review if there is a valid concern should an emergency occur, that would put staff and students in danger.
  - Rollins Presents background of school and church (13:59)
    - Rapid growth at school since 1948 and a road (Oak St ) ran through the center of the campus closed in 1999 (Ordinance 1999-908) (14:13)
  - Rollins shares a map of the school where they mainly identify the buildings by Building name.
    - RPDS is requesting recommendations and feedback from the board
  - *A major concern of RPDS is the building at 830 Oak St. (15:55)*
    - *830 Oak St is located right next to an adjacent building 830 Oak St Unit 1, only separated by a breezeway.*
      - *A joint solution between RPDS and Addressing was to identify the buildings with Large Noticeable Address numbers on the Visible face of the building.*
      - *Addressing recommendations shares examples of signage that would be helpful to identify the buildings for the board to consider that would satisfy emergency personnel without having to readdress the campus.*
    - Rollins Presents questions for the board to Consider: (18:45)
      - Would direction signs through the campus be enough to prevent emergency confusion?
      - Listing Buildings with Large Address numbers be sufficient
      - Registering a site with a Master key to First responders be

- Chairman Whitfield Clarifies what the goal of bringing to the committee- Rollins restates the concern for first responders in emergency situations and is the 800 numbers across the board on all streets enough to create confusion in an emergency clarifying it as a 911 Emergency and needs to be readdressed. (19:20)
- Chairman Clay discusses the Oak St Elimination and how that has created a layer to the confusion. Chairman suggests drawing a private continuation of oak St through the campus for routing purposes. Brown confirms that would be possible. (20:30)
- Gorder asks if there is a fence surrounding the perimeter distinguishing the school is all one property (25:11)
  - Meyer lists where fences are located, however there does not appear one that distinguishes it as a whole property.
- Pollock asks if there has ever been an incident that required emergency attention
  - Meyer confirms no such issues to date; the concern of emergency personnel would show up to the
- The board suggested ultimately that Addressing would send over contacts for the Emergency action would be for the client to reach out to local responding agencies to coordinate proper display of address numbers and potential future addressing changes (if necessary, which would go BACK to the committee for review). Additionally, that the client identifying the buildings by clearly marked large Address numbers.

- This nonconforming address issue was brought forward when a customer brought the address sequencing of several structures forward.
- 8907 2<sup>nd</sup> Ave assigned out of sequence with no room between 8911 and 8913. (47:25)
- Address points cannot simply be swapped due to USPS continuing mail delivery for one (1) year to old address. Multiple addresses may need to be changed. (47:39)

- New proposed name: (1:00)
  - **Tower Court**
    - New assigned addresses:
    - Jacksonville Jaguars Corporate Office: 1 Tower Court
    - Shipyards Marina Support Building: 5 Tower Court

### **Catherine St to Henry Bradley Place (1:16.26)**

#### **(Brown Presents)**

Co-sponsored by city council members Peluso and Johnson

- Henry Bradley was the first firefighter to die in the line of duty on December 16<sup>th</sup>, 1885.
  - Proposal will rename a portion of Catherine Street to Henry Bradley Place.
  - Proposal will rename the relocated fire museum to Henry Bradley Firefighters Museum (1:17.25)
- **New proposed name:**
  - **Henry Bradley Place**
- Brown Shares extent Maps on screen (1:18.30)
  - Includes historic Sandborn maps from 1897 (1:18.35)
- **Affected Property/Entity Owners: (1:19.00)**
  - Currently there are no properties or structures addressed from this portion of Catherine Street.
  - Relocation of the fire museum to the southeast corner of Bay Street East and Catherine Street per CDN#: 616.338 from 1406 Gator Bowl Blvd. (1:19.24)
    - ▶ Fire Museum addressed as: 620 Bay St E
      - ▶ Should a new address for the Museum be established for the renaming of the street and the Museum itself?
        - ▶ Example: 1 Henry Bradley Place (if approved).
        - ▶ Fire museum fronts Bay St E.
  - USS Orleck Museum sits at the end of this portion of Catherine Street.
    - ▶ Currently addressed as 610 Bay St E
    - ▶ Only accessible via the portion of road proposing to be renamed. (1:20.16)
  - Brown Shares Map regarding the Fire Museum relocation CDN: 616.338 on screen (1:20.24)
  - Brown Shares the current Addresser on screen for this location

  - ▶ Duplicate street ranges is identified
