6 **ORDINANCE 2026-248-E**

7 AN ORDINANCE ESTABLISHING THE FISCAL YEAR 2026-
8 2027 ALLOCATION OF FUNDING PERCENTAGES FOR THE
9 OPIOID SETTLEMENT PROCEEDS FUNDED CATEGORIES,
10 AND ESTABLISHING THE FISCAL YEAR 2026-2027
11 OPIOID SETTLEMENT PROCEEDS GRANT APPLICATION
12 PROCESS, IN ACCORDANCE WITH CHAPTER 84 (OPIOID
13 SETTLEMENT PROCEEDS GRANTS), *ORDINANCE CODE*;
14 PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, the Opioid and Substance Use Disorder ("OSUD") Grants
17 Committee met on February 23, 2026, to approve its recommendations
18 for Fiscal Year 2026-2027 to use the grant application process
19 outlined in Chapter 84 (Opioid Settlement Proceeds Grants), *Ordinance*
20 *Code*, and the allocation of funding percentages for the Opioid
21 Settlement Proceeds funded categories; a copy of the minutes of said
22 meeting are attached hereto as **Exhibit 1**; and

23 **WHEREAS**, the City Council, having considered the
24 recommendations of the OSUD Grants Committee, hereby establishes the
25 Fiscal Year 2026-2027 allocation of funding percentages for the Opioid
26 Settlement Proceeds funded categories and the Fiscal Year 2026-2027
27 grant application process; now therefore

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Allocation of Funding Percentages for Opioid**
30 **Settlement Proceeds Funded Categories Established.** Pursuant to
31 Section 84.303 (Opioid Settlement Proceeds Funded Categories), Part

1 3 (Opioid Settlement Proceeds Grant Awards Procedures), Chapter 84
2 (Opioid Settlement Proceeds Grants), *Ordinance Code*, the following
3 allocation of funding percentages for the Opioid Settlement Proceeds
4 funded categories, as recommended by the OSUD Grants Committee in the
5 letter attached hereto as **Exhibit 2**, is hereby established for Fiscal
6 Year 2026-2027:

7 **2026-2027 Allocation of Funding Percentages for**
8 **Opioid Settlement Proceeds Funded Categories**

- 9 **1. Prevention.** The percentage of available funding allocated
10 to this category shall be 34%.
11 **2. Treatment.** The percentage of available funding allocated
12 to this category shall be 33%.
13 **3. Recovery Support.** The percentage of available funding
14 allocated to this category shall be 33%.

15 **Section 2. Process of Selecting Recipients of Opioid**
16 **Settlement Proceeds Grants Established.** Pursuant to Section 84.303
17 (Opioid Settlement Proceeds Funded Categories), Part 3 (Opioid
18 Settlement Proceeds Grant Awards Procedures), Chapter 84 (Opioid
19 Settlement Proceeds Grants), *Ordinance Code*, the process of selecting
20 recipients of Opioid Settlement Proceeds Grants for Fiscal Year 2026-
21 2027 shall be the grant application process outlined in Chapter 84,
22 *Ordinance Code*, as recommended by the OSUD Grants Committee in the
23 letter attached hereto as **Exhibit 2**.

24 **Section 3. Opioid Settlement Proceeds Grants to Serve**
25 **Funded Categories.** Opioid Settlement Proceeds Grants made by City
26 Council shall be used to exclusively serve the Opioid Settlement
27 Proceeds Grants funded categories. Where a category contains more
28 funding than applied for, the excess funding for that population may
29 be applied to another category that contains less funding than applied
30 for. Where more than one category has fewer funds than applied for,
31 the excess funding shall be divided among the underfunded categories

1 on a percentage basis where the total amount underfunded in all
2 underfunded categories is the denominator and the amount underfunded
3 in any one category is the numerator.

4 **Section 4. Effective Date.** This Ordinance shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
