4 **ORDINANCE 2024-379**

5 AN ORDINANCE CONCERNING THE CITY OF JACKSONVILLE  
6 SAFETY AND CRIME REDUCTION COMMISSION; AMENDING  
7 SECTION 78.107 (SUNSET PROVISION), CHAPTER 78  
8 (SAFETY AND CRIME REDUCTION COMMISSION),  
9 *ORDINANCE CODE*, TO PROVIDE FOR SUNSET OF THE  
10 COMMISSION ON DECEMBER 31, 2024; PROVIDING FOR  
11 CODIFICATION INSTRUCTIONS; PROVIDING AN  
12 EFFECTIVE DATE.

14 **WHEREAS**, pursuant to Section 78.107, *Ordinance Code*, the  
15 Safety and Crime Reduction Commission (the "Commission") is currently  
16 scheduled to sunset on July 1, 2025, unless further extended by  
17 Council action; and

18 **WHEREAS**, a review of the current progress of the Commission,  
19 including all outstanding funded grant obligations and other pending  
20 contracts has been conducted to ascertain whether the aforementioned  
21 sunset date would be appropriate; and

22 **WHEREAS**, the Council desires to acknowledge and applaud the  
23 success of the Commission and the current and former slate of  
24 Commissioners and affiliated former Council Members in carrying out  
25 the mission and purpose for which the Commission was established as  
26 outlined in Section 78.101, *Ordinance Code*, and has determined it  
27 appropriate and in the City's and Commission's best interests to  
28 adjust the sunset date of the Commission to occur on December 31,  
29 2024; now therefore

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

31 **Section 1. Amending Section 78.107 (Sunset Provision),**

1 **Chapter 78 (Safety and Crime Reduction Commission), Ordinance Code.**  
2 Section 78.107 (Sunset Provision), Chapter 78 (Safety and Crime  
3 Reduction Commission), *Ordinance Code*, is hereby amended to read as  
4 follows:

5 **CHAPTER 78 - SAFETY AND CRIME REDUCTION COMMISSION**

6 \* \* \*

7 **Sec. 78.107. - Sunshine Provision.**

8 This ~~Chapter~~Section shall sunset on December 31, 2024, ~~July 1,~~  
9 ~~2024~~ unless, prior to the Sunset date, the City Council shall pass  
10 legislation to extend the Commission.

11 **Section 2. Codification Instructions.** The Codifier and the  
12 Office of General Counsel are authorized to make all chapter and  
13 division "tables of contents" consistent with the changes set forth  
14 herein. Such editorial changes and any others necessary to make the  
15 *Ordinance Code* consistent with the intent of this legislation are  
16 approved and directed herein, and changes to the *Ordinance Code* shall  
17 be made forthwith and when inconsistencies are discovered.

18 **Section 3. Effective Date.** This Ordinance shall become  
19 effective upon signature by the Mayor or upon becoming effective  
20 without the Mayor's signature.
