AN ORDINANCE CONCERNING THE CITY OF JACKSONVILLE SAFETY AND CRIME REDUCTION COMMISSION; AMENDING SECTION 78.107 (SUNSET PROVISION), CHAPTER 78 (SAFETY AND CRIME REDUCTION COMMISSION), ORDINANCE CODE, TO PROVIDE FOR SUNSET OF THE COMMISSION ON DECEMBER 31, 2024; PROVIDING FOR CODIFICATION INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 78.107, Ordinance Code, the Safety and Crime Reduction Commission (the "Commission") is currently scheduled to sunset on July 1, 2025, unless further extended by Council action; and

WHEREAS, a review of the current progress of the Commission, including all outstanding funded grant obligations and other pending contracts has been conducted to ascertain whether the aforementioned sunset date would be appropriate; and

WHEREAS, the Council desires to acknowledge and applaud the success of the Commission and the current and former slate of Commissioners and affiliated former Council Members in carrying out the mission and purpose for which the Commission was established as outlined in Section 78.101, Ordinance Code, and has determined it appropriate and in the City's and Commission's best interests to adjust the sunset date of the Commission to occur on December 31, 2024; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amending Section 78.107 (Sunset Provision),

Chapter 78 (Safety and Crime Reduction Commission), Ordinance Code.

Section 78.107 (Sunset Provision), Chapter 78 (Safety and Crime Reduction Commission), Ordinance Code, is hereby amended to read as follows:

## CHAPTER 78 - SAFETY AND CRIME REDUCTION COMMISSION

\* \* \*

Sec. 78.107. - Sunshine Provision.

This <u>ChapterSection</u> shall sunset on <u>December 31, 2024, July 1, 2024</u> unless, prior to the Sunset date, the City Council shall pass legislation to extend the Commission.

Section 2. Codification Instructions. The Codifier and the Office of General Counsel are authorized to make all chapter and division "tables of contents" consistent with the changes set forth herein. Such editorial changes and any others necessary to make the Ordinance Code consistent with the intent of this legislation are approved and directed herein, and changes to the Ordinance Code shall be made forthwith and when inconsistencies are discovered.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
