7 AN ORDINANCE APPROPRIATING \$4,028,251 FROM
8 GENERAL FUND OPERATING RESERVES TO THE SOLID
9 WASTE DISPOSAL FUND - CONTRACT GARBAGE AND
10 RECYCLING ACCOUNT, TO FUND THE MONTHLY PER
11 PREMISE RATE OF \$22.39 AUTHORIZED BY THE CITY
12 COUNCIL FOR RESIDENTIAL CURBSIDE SOLID WASTE AND
13 RECYCLABLES COLLECTION AND TRANSPORTATION
14 SERVICES PROVIDED BY MERIDIAN WASTE FLORIDA,
15 LLC, FOR FISCAL YEAR 2024-2025; APPROVING AND
16 AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE
17 CORPORATION SECRETARY TO EXECUTE A FIRST
18 AMENDMENT TO CONTRACT BETWEEN CITY OF
19 JACKSONVILLE AND MERIDIAN WASTE FLORIDA, LLC,
20 FOR RESIDENTIAL CURBSIDE SOLID WASTE AND
21 RECYCLABLES COLLECTION AND TRANSPORTATION
22 SERVICES (SERVICE AREA II), SETTING RATES
23 COMMENCING OCTOBER 1, 2024, SETTING FUEL CAPS
24 FOR FISCAL YEARS 2024-2025, 2025-2026 AND
25 2026-2027, AND APPROVING THE PREMISE COUNT
26 CONDUCTED IN CONNECTION WITH THE RATE REVIEW;
27 PROVIDING A MONTHLY BASE RATE; PROVIDING FOR
28 CITY OVERSIGHT BY THE SOLID WASTE DIVISION OF
29 THE DEPARTMENT OF PUBLIC WORKS; PROVIDING AN
30 EFFECTIVE DATE.

1 Fund - Contract Garbage and Recycling account, to fund the
2 monthly per premise rate of \$22.39 authorized by the City
3 Council for residential curbside solid waste and
4 recyclables collection and transportation services
5 provided by Meridian Waste Florida, LLC for fiscal year
6 2024-2025.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to fund the increased monthly per premise rate of \$22.39
9 for residential curbside solid waste and recyclables collection and
10 transportation services provided by Meridian Waste Florida, LLC, as
11 authorized herein.

12 **Section 3. Monthly Base Rate.** The recommended terms
13 established by the Council rate review process pertaining to the
14 Contract between the City and Meridian are as set forth in **Exhibit**
15 **1**, attached hereto and incorporated herein by this reference. The
16 monthly base rate component of \$18.29 recommended by said rate review
17 process as set forth in **Exhibit 1** is inclusive of a mark-up on
18 operating expenses before profit, interest expenses, and corporate
19 taxes. After careful consideration of the recommendations arising out
20 of the Council rate review process and receipt of additional
21 information from Meridian, the City Council has determined it
22 appropriate and hereby approves and authorizes an adjustment to the
23 Monthly Base Rate Component commencing October 1, 2024, to \$22.39 per
24 premise which shall be adjusted thereafter, if necessary, pursuant
25 to the Agreement. With the exception of the foregoing, all other
26 terms established by the Council rate review process as outlined in
27 **Exhibit 1** are hereby approved.

28 **Section 4. Approval and Authorization to Execute First**
29 **Amendment to Contract.** The Mayor, or her designee, and the
30 Corporation Secretary are hereby authorized to execute that certain
31 First Amendment to Contract Between City of Jacksonville and Meridian

1 Waste Florida, LLC for Residential Curbside Solid Waste and
2 Recyclables Collection and Transportation Services (Service Area II)
3 (the "First Amendment") in substantially the same form attached hereto
4 as **Revised Exhibit 2** and incorporated herein by this reference. The
5 First Amendment incorporates the terms approved by Council as set
6 forth in Section 3 of this Ordinance.

7 **Section 5. Oversight.** The Solid Waste Division of the
8 Public Works Department shall oversee the Contract described herein.

9 **Section 6. Effective Date.** This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
