A RESOLUTION HONORING THE LIFE AND MOURNING THE PASSING OF DR. WILLIAM LEWIS CODY SR.; PROVIDING AN EFFECTIVE DATE.

9 WHEREAS, Dr. William Cody Sr. was a devoted husband to his 10 wife Betty for 51 years, he was a loving father to his children, 11 William Jr. and the late Caroline, and he was a doting grandfather 12 to Laurel and Elliott; and

WHEREAS, Dr. William Cody Sr. was a caring physician in Jacksonville for more than 30 years. He was named the Department Head of Obstetrics and Gynecology Division at the Naval Air Station in 16 1990 and opened his private practice the next year. He was nominated 17 by his OBGYN peers for his expertise to be included in the Best 18 Doctors Inc. database and was recognized as "Top Rated" amongst First 19 Coast Physicians; and

20 WHEREAS, in 2020, Dr. Cody retired as Managing Partner of St. 21 Vincent's Hospital Division IV of North Florida OBGYN, after a 22 distinguished career and delivering more than 4,100 babies; and

23 WHEREAS, Dr. Cody was a military veteran and a faithful 24 congregant at the Bethel Church. He was a trusted friend, and a valued 25 mentor to doctors in training. In 2014, Dr. Cody was honored with the 26 OneJax Institute's Humanitarian Award in recognition of the countless 27 hours he spent mentoring and teaching in the St. Vincent's family 28 practice residency; and

WHEREAS, Dr. Cody served as Polemarch of Kappa Alpha Psi Fraternity, Inc., Jacksonville, Florida Alumni Chapter, and chaired the group's annual charity golf tournament for 18 years to raise 1 funds for numerous scholarships to deserving high school seniors. He 2 served as President of the Deerwood Rotary Club, leading fundraising 3 efforts for the First Tee of North Florida, Duval County Teacher of 4 the Year, Early Learning Coalition of Duval, Samuel W. Wolfson High 5 School Interact Club, and St. Boniface Haiti Foundation; and

6 WHEREAS, Dr. William Cody Sr. treasured his family and made 7 time to travel the world with them each year. He also prioritized his 8 patients, striving to not just be a doctor, but to be a good doctor; 9 now therefore
