5 **ORDINANCE 2022-214-E**

6 AN ORDINANCE REGARDING CHAPTER 118 (CITY
7 GRANTS), *ORDINANCE CODE*; ESTABLISHING THE 2022-
8 2023 CATEGORIES OF MOST VULNERABLE PERSONS AND
9 NEEDS FOR PUBLIC SERVICE GRANT APPROPRIATIONS;
10 PROVIDING AN EFFECTIVE DATE.

12 **WHEREAS**, the Public Service Grant Council met on February 28,
13 2022 to approve the Fiscal Year 2022-2023 Most Vulnerable Persons and
14 Needs, a copy of the minutes of said meeting are attached hereto as
15 **Exhibit 1**; and

16 **WHEREAS**, the City Council through this ordinance is hereby
17 establishing the Most Vulnerable Persons and Needs for the 2022-2023
18 Fiscal Year; now therefore

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Categories of Most Vulnerable Persons and Needs**
21 **Established.** Pursuant to Section 118.804, (Categories of Most
22 Vulnerable Persons and Needs), *Ordinance Code*, the following
23 categories of Most Vulnerable Persons and Needs, as recommended by
24 the Public Service Grant Council in the letter attached hereto as
25 **Exhibit 2**, are hereby established for the 2022-2023 Fiscal Year:

26 **2022-2023 Categories of Most Vulnerable Persons and Needs**

27 **1. Acute.** The percentage of available funding allocated to
28 this category shall be 30%.

29 **2. Prevention.** The percentage of available funding allocated
30 to this category shall be 40%.

31 **3. Self-Sufficiency.** The percentage of available funding

1 allocated to this category shall be 30%.

2 **4. Micro-Grant Pilot Program.** The percentage of available
3 funding to this category shall be 0% of the PSG budgeted funds due
4 to the funds for the micro-grants pilot program being funded
5 separately from the normal PSG Council Award/Budget process.

6 Detailed definitions of each of the categories of Most
7 Vulnerable Persons and Needs are set forth in **Exhibit 3.**

8 **Section 2. Public Service Grants to Serve Categories of**
9 **Most Vulnerable Persons and Needs.** Public Service Grants made by
10 City Council shall be used to exclusively serve the categories of
11 Most Vulnerable Persons and Needs. Where a category contains more
12 funding than applied for, then the excess funding for that population
13 may be applied to a category that contains less funding than applied
14 for. Where more than one category has fewer funds than applied for,
15 then the excess funding shall be divided among the underfunded
16 categories on a percentage basis where the total amount underfunded
17 in all underfunded categories is the denominator and the amount
18 underfunded in any one category is the numerator.

19 **Section 3. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
